2015 MINUTES FRIDAY MORNING

The one hundred and forty sixth annual session of the Central Indiana Association of Separate Baptist in Christ, Inc. convened at the Midway Campground on Friday, September 11th, 2015 at 10:00 AM. The moderator, Rev. Donnie Wiggington welcomed everyone to this setting of our association reminding everyone that the altar is open all day long for any spiritual needs. The moderator asked Bro. Jim Tucker to lead the body in prayer. Bro. Donnie asked Bro. Benny Walden led the congregation in singing. He led *“Blessed Assurance”* & *“Jesus Is All the World to Me”* while Sis. Phyllis Wiggington played the piano and Rev. Donnie Wiggington played bass.

The moderator asked Bro. Roger Sink to come forward to lead the devotional service. Bro. Roger read John 10:1-16, Acts 4:12 & John 3:16. Bro. Roger encouraged us to trust in Jesus Christ and him only. Prayer requests were made by the congregation and Rev. Terry Thrasher led in an altar of prayer.

The moderator led the congregation in the pledges to the American and Christian Flags, and the Holy Bible. The moderator asked that all standing delegates from the Central Indiana Association, which include all Ministers, Deacons, and Sunday School Superintendents, to stand in order to constitute a quorum. A total of 26 standing delegates were present. The moderator asked the standing delegates if they will work with one another during this setting of the association. All voted in peace.

- The letter from the East Columbus church was mentioned as present but that there was no information in the letter and the letter was not signed. The Clerk then read each of the following church letters: Edinburgh, Franklin, Friendship Decatur (Rodney), Great Hope, Indianapolis, Jewell Village, Mount Zion, Pleasant Valley, Salem, Shiloh and Union Laymon. A motion was made after the reading of each letter to accept it, print the necessary information in the minutes, and seat the delegate(s) present and those who may come in later. Each motion was seconded and passed. The delegates were recognized after each letter was read and were seated in fellowship by the moderator.
- The moderator called for new churches. There were none.
- The moderator asked all delegate, standing and lay delegates to stand and asked Rev. John Perkins to ask God’s blessing on this association.
- The appointment of the Divine Services Committee was then made. This committee consisted of Rev. Jim Stump - (Chairman), Bro. Bill Ridge & Bro. Zach Owensby.
- All visiting ministers and deacons were asked to stand to be recognized. The visitors included Rev. Danny Bailey, Rev. Terry Thrasher & Rev. Silas Thrasher all of the South Kentucky Association. Bro. Donnie then asked all other visitors to stand and welcomed each visitor and thanked them for their support.

- Bro. Donnie called for an offering (designated to go to the kitchen committee) be taken up. Rev. Matt Satter asked the blessing on the offering which amounted to \$303.00. The congregation sang *“Victory In Jesus.”*

The moderator then spoke of the tragedy of 9/11 mentioning he remembers that day and where he was when he heard of the attacks. He spoke of our nation coming together for a short time. He spoke that even though we are not as united today we as Christians need to hold tighter to the hand of a living God and cry to God for revival. He asked all in attendance who has served in the armed forces to stand. The moderator asked the congregation to show their love and support for these men with a round of applause. The congregation then responded in kind. Rev. Lonzo Wiggington led in a prayer for active service personnel and their families.

Bro. Donnie spoke to how the preaching is his favorite part of the association. He then asked Rev. Matt Satter to come forward and preach the introductory sermon. Bro. Matt greeted everyone and asked for the prayers of those in attendance.

Bro. Matt stated he wants to introduce us to the God he serves, the God we all serve. He read from 1 Samuel 3:4 “That the Lord called Samuel: and he answered Here am I.” Bro. Matt encouraged us to hold to the teaching of the Bible and follow God as he directs us. The world today continues to “play god” and try to change what is very good according to the Word of God. God gives us a free will and it is our responsibility to choose to serve God. He encouraged us to keep the faith and continue to work for the Lord regardless of our age or experience. He asked us to listen to the leading of the Holy Spirit when we go to the polls to elect our leaders. He spoke of Jesus coming to John to be baptized and John forbade but Jesus instructed John this was his calling and duty. We too must answer the call and do our duty. People want to get close enough to the Lord to feel better but don’t want to commit their live completely to the Christian walk. “Draw nigh to God and He will draw nigh to you”. Bro. Matt spoke of several from the Bible and their calling and walk with God then spoke of his own calling and how the convicting power of the Holy Spirit brought him to know the need to repent then answer the call to preach. Bro. Matt called for a song. We stood and sang “What a Day” for an invitation hymn.

Bro. Donnie thanked Bro. Matt for the sermon and asked if anyone wished to share their experience. Many testimonies were shared. Bro. Donnie asked that the Divine Services committee report be read. Due to the strong winds of spring, one of the roof vents was raised up and approximately 4-5 shingles were damaged over the entry area. This damage has been successfully repaired.

We wish to thank all who came and assisted in preparing the property for the 2015 Youth Camp. Due to the great turnout, the swings, basketball equipment, volleyball court and preparations in the sanctuary and dining area were completed in short order. We also appreciate those who disassembled the equipment and those who stayed after the Friday night service to assist in cleaning the sanctuary and cleaning the bathrooms.

At the start of the 2015 Youth Camp, it was found that the water heater in the kitchen area had stopped working. A new water heater was purchased and installed. In order to remove the old and install the new, a hole was made in the south wall in order to provide access. That hole is now covered by an access panel.

This past year Brother Charles Tichenor had to step down as pastor of Midway church because of his declining health. Due to the lack of a replacement pastor, weekly church services are no longer held in this facility. The building and premises are now strictly used for association events such as Fifth Sunday meetings, Ministers and Deacons Institute Meetings, Youth Camp, Camp Meeting and Annual Association. The Board of Trustees has asked that all of the churches consider sending a monthly offering to the campgrounds treasurer in order to provide funds required to pay the utility bills, insurance, maintenance and general upkeep of the property. We wish to thank those churches who already began to do so.

Recently services ceased to be held at the property of the East Columbus Separate Baptist Church located at 452 S Mapleton St, Columbus IN. This very difficult decision was made by the congregation due to lack of attendance and

funds. The property has been turned over to the trustees and they will be working to determine the future of this property.

The board of trustees met Saturday morning, September 12, 2015, and elected Bro. Stacy Wiggington to a five year term as trustee replacing Bro Rick Owensby.

SBMI REPRESENTATIVE

The SBMI board met on October 10, 2014 at the Nollynn Campground during the annual General Association. We met with Brothers Jerry Ridge and Lonnie Palmer. Brother Palmer had asked to meet with the board to discuss his recent trip to the Ivory Coast with Steve and their meeting with the churches there. He shared some concerns regarding the work. After Brother Lonnie left the meeting, we continued to discuss some of these issues and then moved on to discuss Brother Jerry's future trips to the Ivory Coast. We also discussed the needs of the home missions that had been brought to our attention.

On March 28, 2015, we met again at the Okolona Separate Baptist Church in Louisville KY. We met with Brother Jerry to discuss the details of his trip to the Ivory Coast planned for the latter part of June and my intention to make the trip with him this year. We discussed the purchase of the new truck. We found that due to the current exchange rate, we would save money if we bought the truck now in lieu of taking the payment with us. The funds were available and it was decided to wire the money to the dealership and have the truck waiting for pick up once we arrived. We also discussed the possibility of looking for a piece of land in order for the Separate Baptists to build their own mission house. We then moved on to discussing home missions and the various needs of our churches.

On June 25th, Brother Jerry and I boarded a plane in Louisville and journeyed to the Ivory Coast. We were there from June 26th to July 25th. The first item of business was obtaining the truck. A 2015 TATA was prominently parked at Ivorie Motors in Abidjon when we arrived. The truck proved to be a great blessing during our travels and held up well as we put it to the test while travelling up country.

We also found and purchased a piece of land for a mission house. The property is approximately 1/3 of an acre located in Bondoukou just a few yards from the church and dorms. The property has been cleared of trees and brush. Fourteen mango trees have been planted to shade the house once built. Funds were also left with a mason to begin making concrete block for the house. We have received word that approximately 1,400 blocks are made and waiting for

construction to begin. This is about 1/3 of the number of blocks that will be needed for the construction of the house. This new house will have running water and electricity. These are basic amenities that the current house, used in Laudi, does not have.

We were blessed to attend the dedication service for the new church building in Nassian. This building was built by the financial gifts that were sent by the Separate Baptist Churches. In this case, the majority of funds were donated by the Zion Church of the Nollan Association. The church sign over the doors states "Nassian Free Baptist Church" and just under it is another sign stating that the building is a gift from the Separate Baptist Churches USA. We also saw the progress of the new church building at De'de. Through your gifts the walls are up and the roof is now on this building. The money you provide is building churches spiritually and physically.

As with every trip to the Ivory Coast, the most important order of business is the opportunity to visit with the churches and evangelize in the villages. If my count is accurate we visited 13 of the churches and evangelized in 3 villages during this trip. All of the churches we visited asked that we convey their gratitude to the Christians in the U.S. for their fellowship and support. We were blessed to witness two conversions while evangelizing in the village of Salemey.

We continue to encourage all of our churches to support the mission work of the SBMI. Both home and foreign missions are a vital part of the ministry. Your donations have allowed us to obtain a new truck in order to provide a means of safe, comfortable and dependable travel for our representatives while in the Ivory Coast. We now ask that you support and fund the building of the mission house for the very same reasons.

Equally important is the work of our home missions. During this past year, we had the opportunity to assist our churches who needed help in paying utility bills, insurance payments and basic maintenance needs in order to keep their doors open. We also assisted Rev John Perkins in purchasing a new tent for his evangelistic ministry. This new tent has a more modern look and is much larger. He immediately began putting it to use.

Central Indiana resolution from the Constitution Committee:

We your committee responding to same sex marriage submits the following: Be it resolved that this association defines a man as one who, at birth, is a biological man. A woman is defined as one who, at birth, is a biological woman. Furthermore, using the above definitions, this association defines “holy matrimony” as the marriage union between one man and one woman

Finally, using all the definitions above, this association forbids

- Any member minister from participating, in any manner, in a marriage ceremony other than holy matrimony
- Any member church or associational properties being used in any marriage ceremony other than holy matrimony.

This committee also advises our churches to pursue similar declarations at the church level.

This committee also advises that this resolution be reworded from a resolution to a by-law.

ARTICLES OF DOCTRINE

1. We believe that the Scriptures of the Old and New Testaments are the infallible Word of God and the only safe rule of faith and practice, using the King James version of the Holy Bible. * II Tim. 3:16-17; I Cor. 10:11; II Peter 1:20-21

2. That there is in the God-Head three divine personages; Father, Son, and the Holy Spirit. I John 5:7; Matt. 28:19; Matt. 3:15-17

3. That man is in a fallen state before God, and is unable to liberate himself by any ability we possess by nature. Isa. 63:1-5; I Cor. 15:22; Ps. 51:5; John 14:6

4. That salvation, regeneration, justification, sanctification and redemption are through faith in the life, death, resurrection, ascension, and intercession of the Lord and Saviour Jesus Christ. John 17:19; Acts 13:39; Titus 2:14; Rom. 3:24-26

5. We believe that he who endures to the end the same shall be saved. Rev. 2:10; Matt. 24:13

6. That the joys of the righteous and punishment of the wicked will be eternal. Matt. 25:46; Dan. 12:2; Rom. 5:21

7. We believe that baptism, the Lord's Supper and feet washing are ordinances of Jesus Christ, appointed in the Church, and none but true believers are proper subjects, and the only proper mode of baptism is immersion of believers. Matt. 28:19-20; Acts 2:41; John 13:14; I Peter 3:21; Matt. 3:14; I Cor. 11:23-26

8. We believe in the sanctity of the first day of the week or Lord's Day, which ought to be observed and spent in public or private worship of God and that we should abstain from worldly concerns except in cases of necessity or mercy. Acts 20:7; I Cor. 16:2

9. We believe in the resurrection of the body, both of the just and the unjust, but every man to his own order. Those who have done good, to the resurrection of life, and those who have done evil to the resurrection of damnation, and that God hath appointed a day in which He will judge the world in righteousness by Jesus Christ. I Thes. 4:16; I Cor. 15; John 5:28-29

10. That it is our duty to be tender and affectionate one to another and in honor preferring one another, to study the happiness of God's people in general and do all we can to support, promote, and spread the Gospel. Rom. 12:10; Luke 14:23

11. We believe that Jesus Christ, by the grace of God, tasted death for everyone, and that all may partake of his Divine benefits through repentance toward God and faith in the Lord Jesus Christ. Also, infants and those who have never developed the mental ability to receive regeneration, are included in the covenant of God's grace. John 3:15-17; Acts 4:12

* the King James Version of the Bible being the choice for English speaking people.

CONSTITUTION

THE PREAMBLE

The name of this Association shall be called the Central Indiana Association of Separate Baptist in Christ, Incorporated, and we agree to be governed by the following Constitution:

ARTICLE I

Section 1. This body shall be composed of lay delegates sent from different churches, and Ministers, Deacons and the Sunday School Superintendents from Sunday Schools of the churches comprising the body, if they are members of the Separate Baptist Church.

Section 2. Each church comprising the body of this Association shall be entitled to 2 lay delegates for the first 25 members or fraction thereof; one lay delegate for each additional 25 members or fraction thereof.

ARTICLE II

Section 1. The officers of this Association shall include the following: Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and Assistant Treasurer, who shall be elected and hold their office one associational year, and a Board of Trustees composed of five members selected by vote of delegates appointed by the churches; each church to be allowed one delegate. No church is to have more than one Association Trustee serving at one time. If a trustee is from your church he will automatically be the voting delegate when the new trustee is to be elected. The Chairman of the Trustees will preside over the meeting. Members of the first Board of Trustees shall serve 1,2,3,4 and 5 years respectively. Thereafter, each member shall be elected for five years, one members term of office to expire at each annual session.

Section 2. The duties of the Moderator shall be to preside at all meetings, be it either business or divine worship, and to appoint all committees except the Constitutional Committee, and to cast the deciding vote in case of a tie.

Section 3. The Assistant Moderator shall perform all duties of the Moderator in the absence of the Moderator.

Section 4. The duties of the Clerk shall be to make complete written record of the proceedings of all meetings of this body and keep a file record of the same, and carry on all correspondence.

Section 5. The duties of the Assistant Clerk shall be to perform the duties of the Clerk in the absence of the Clerk.

Section 6. The duties of the Treasurer shall be to receive all money and pay out the same upon order of the Trustees.

Section 7. The duties of the Assistant Treasurer shall be to perform the duties of the Treasurer in case the Treasurer is not able to perform his duties or is deceased.

Section 8. The duties of the Board of Trustees shall be to decide all questions arising under the constitution and by-laws of the association and to have the responsibility of the care and upkeep of all associational properties.

ARTICLE III

This body shall meet once each year (or more often) if called by the Moderator.

ARTICLE IV

No delegate shall absent himself from this body while in session without permission from the Moderator.

ARTICLE V

No person has the right to perform the Ordinance of God's House unless legally ordained according to the mode adopted by the Separate Baptist Association.

ARTICLE VI

Section 1. This association shall have a Mission Board consisting of five members. The members of this Board, shall be appointed by the Moderator.

Sections 2. The duties of the Mission Board shall be to solicit the support of our churches and ministers, and to organize new churches and Sunday Schools. The churches of the association shall raise a fund necessary for this. The Mission Board shall solicit each church for support.

Section 3. The duties of the Mission Board shall be also to take care of any mission money sent in by the different churches.

ARTICLE VII

Section 1. This body shall have a Presbytery composed of five ordained ministers appointed by the moderator.

Section 2. The duties of the Presbytery shall be to attend the examination and ordination of all candidates for the ministry and deacons in the churches.

Section 3. If any church of this association wishes to ordain a deacon, they shall notify the Presbytery by letter, not less than three members of the Presbytery shall be present to examine the candidate and if found worthy to set apart or ordain. The Presbytery then may, if needed, ask any ordained personnel of this association to assist in the ordination only at which time the candidate shall be given a certificate of ordination.

Section 4. The qualifications required of those seeking ordination to the ministry are set forth in the by-laws of this association. The duties of the board shall extend from one session to another, and said board shall make a report at each meeting.

ARTICLE VIII

This association shall have a Young Peoples Department, to be known as the Young Peoples Separate Baptist Union. Its officers shall be a President, Vice-President, Secretary, and Treasurer. It will include all the Young Peoples Separate Baptist Unions of the association and will hold at least one meeting a year for the purpose of promoting the Young Peoples Work. Other meetings may be held upon call by the President. All officers shall be elected at the regular annual meeting. The Union may draft its own by-laws, but no by-laws shall be accepted which will conflict with or be in disagreement with the belief of the Separate Baptist Church. Said Young Peoples Separate Baptist Union shall make a report at each association.

ARTICLE IX

This constitution, By-Laws and Articles of Doctrine may be changed or amended by a two-thirds vote of the association after an amendment has been submitted by a committee selected by the association for that purpose and after having been tabled for a period of one associational year. All amendments shall be submitted to the committee before being voted upon by the association. Said committee shall be composed of three members elected by the associational delegates. Members of the first Constitutional Committee shall serve one, two, three years respectively. Thereafter, each member shall be elected for three years, one members' term of office to expire at each annual association.

BY-LAWS

ARTICLE I

Any church applying for membership in this body by letter or delegate shall be requested to give evidence of orthodoxy and agree to comply with the rules of this body before being received.

ARTICLE II

When any minister seeks membership in this body, or licentiate seeks ordination, his church shall notify the Presbytery by letter, the Presbytery shall be appointed at each association. Not less than three members of the Presbytery shall be present to examine him on his faith and doctrine, his standing in the church to which he belongs, his ability to expound the Gospel, and his educational qualifications. Any minister shall be licensed for two years before being set apart or ordained by the Presbytery. Then if found in complete accord with the association's Article of Doctrine, able to intelligently expound the Gospel, and worthy, then the Presbytery may if needed ask any ordained personnel of this association to assist in ordination only.

ARTICLE III

Should any church or any member minister of this body fail to report to this body, the Presbytery shall investigate the cause of such failure and report the same to the association.

If any minister fails to report to the association or fails to pick up his minister's card within 2 years, they shall be placed on file with the association papers.

ARTICLE IV

When more than one candidate is nominated for any office in the association, the election shall be by ballot.

ARTICLE V

This body shall have the power to expel any church, minister, deacon, pastor or member from membership in the body for heterodoxy and disorderly conduct, and shall demand the surrender of credentials to the association. No church shall employ a minister as pastor who is not identified with the Separate Baptist Church, except in case of shortage of ministers, and then only by and with the consent and approval of the Presbytery. Said ministers so employed shall sign an agreement that their preaching shall be in accord with the Articles of Doctrine adopted by this body during his pastorate. The Separate Baptist Church is opposed to the doctrine of sanctification as a second definite work of grace and a thousand years literal reign of Christ, and will not permit its being preached in its churches.

ARTICLE VI

In case of a discussion with any church of this body, and inability of the members of such church to settle such discussion, any member of such church shall have the privilege of calling upon the Board of Trustees of this body, and not upon the association, for settlement, upon giving due notice to the church of said appeal from the decision of such church to said board. The board shall take such action as it shall see fit and necessary in the case. Any member or church, if dissatisfied with the decision and action of the board, may appeal the decision of said board to the association.

ARTICLE VII

It shall be the duty of the moderator of each church body to remind the church body to support the Central Indiana Association and Mission Board with their financial aid.

ARTICLE VIII

The clerk shall receive one hundred dollars annually for his/her services as clerk and shall draw on the treasury to defray expenses in the printing and distribution of the minutes of the association.

ARTICLE IX

No officer of this association shall hold the same office more than five years in succession.

ARTICLE X

All elected and appointed officers of this association shall serve the time for which they are elected and until their successors are duly elected and qualified.

ARTICLE XI

This association may act prudently as protectorate for a limited time toward any church of this association which fails to have any meetings.

ARTICLE XII

This association shall not issue minister cards to licentiate ministers.

ARTICLE XIII

This association forbids the ordination of women as ministers of this body.

ARTICLE XIV

This association prohibits the ordination of homosexuals as ministers or deacons of this body. Also, no person shall be ordained who has more than one living wife or whose wife has more than one living husband.

RULES OF PROCEDURE

1. This association shall be opened and closed with prayer.
2. All officers of this association shall be elected by a majority vote of delegates present.
No one shall be allowed to vote by proxy.
3. All nominations of officers shall be by delegates.
4. Only members who presented the motion under discussion may speak more than once upon the motion, except when he be given permission by the moderator.
5. Any member wishing to speak shall arise and address the moderator and when given permission to speak, must adhere strictly to the subject without casting any reflections upon any previous speaker.
6. No person shall be interrupted when speaking as long as he adheres to the rules and decorum of the association and is casting light upon the subject.
7. Any delegate shall have a right to rise to a point of order any time one speaking is thought out of order by the objector. When recognized by the moderator, the objector may state his point of order. The moderator's decision on the point of order shall be final, unless appealed to the body.
8. Creating disturbances, speaking harshly to a brother, sowing discord, talking off the subject under discussion, or any act creating disturbances, shall be considered out of order.
9. There must be at least twenty delegates present to constitute a quorum.
10. All grievances or complaints that come before the association shall be heard by a committee appointed by the moderator and approved by association. Said committee shall immediately hear the evidence on the complaint or grievance and immediately report their decision to the association. Said decision shall be final unless an appeal is taken to the association.
11. Where these rules fail to provide, the moderator shall be governed by "Robert's Rules of Order."
12. These rules may be amended by a two-thirds vote of the delegates present at the regular association.

RULES & GUIDELINES FOR YOUTH CAMP

Last revised September 10, 2004

1. No Camper shall be permitted to leave the campgrounds without the permission of the committee.
2. All campers must stay out of the woods and stay on the playground.
3. Each camper will be under the supervision of his or her teacher.
4. There will be no smoking while at the campground.
5. All girls must wear dresses or skirts to a length no higher than the knees.
6. Slacks will not be permitted for girls.
7. Boys must wear sleeved shirts and long pants.
8. Shorts will not be permitted for any camper.

MINISTERS AND DEACONS INSTITUTE
CONSTITUTION

PREAMBLE

The name of this association shall be the Ministers and Deacons Institute of Central Indiana Association of Separate Baptists in Christ.

Article I

This body shall be composed of all pastors, licentiate/ordained ministers and ordained deacons of the Central Indiana Association of Separate Baptist Churches.

Article II

Section 1. The officers of this body shall be a Chairman, Assistant Chairman, Secretary/Treasurer and Assistant Secretary/Treasurer, who shall be elected and shall hold this office one year.

Section 2. No member shall be allowed to serve in the same office more than two consecutive years.

Section 3. All committees shall be appointed by the chairman.

Section 4. The Secretary/Treasurer shall make a complete written record of each meeting and keep on file, carry on all correspondence, and keep a record of receipts and expenditures.

Article III

This body shall meet on the third Friday night before the Fifth Sunday Meeting @ 7:00 p.m.

Article IV

Section 1. This institute shall have a program committee of two members of the Institute.

Section 2. The committee will have the responsibility of providing a program that will be acceptable to the chairman and pastor of the host church.

Article V

No one shall be eligible to make motions or speak in the business meeting except pastors, licentiate/ordained ministers or ordained deacons of the Central Indiana Separate Baptist Churches.

YOUNG PEOPLE'S SEPARATE BAPTIST UNION BY-LAWS

JULY 14, 1991

1. The purpose of YPSBU is to gather the Central Indiana Association Young People together for worship and fellowship and to encourage young people to attend church and to be Christians.
2. The YPSBU will have quarterly meetings to be held in accordance with YPSBU President.
3. Officers for the YPSBU will be elected annually at the second quarterly meeting.
4. No officer is to hold the same office for more than three (3) consecutive years.
5. Officers for YPSBU will be as follows:
 - President - conducts quarterly meetings and appoints committee.
 - Vice-President - assist President; hold the position of President in the absence of the President.
 - Secretary and Treasurer - record minutes of meetings; control bank account; handle any correspondence.
 - Assistant Secretary and Treasurer - assist Secretary and Treasurer; hold office in their absence.
 - Song Leader - lead congregational singing at YPSBU quarterly meetings.
 - Assistant Song Leader - assist Song Leader; hold office of Song Leader in their absence.
6. Each quarterly YPSBU meeting will have a program for Young People especially designed by a program committee.
7. There will be a program committee of three members (or one church) appointed by the President at each quarterly meeting. They will be responsible for the following quarterly program.
8. Young People from the ages 10-45 will be eligible to vote in business if they attend one of the Central Indiana Association Churches.
9. The by-laws can be amended by two-thirds majority vote at the YPSBU quarterly meeting.
