






- 1. **Triangle**......Trinity (Father, Son and Holy Spirit) as one.
- 2. **Cross**...... Salvation comes through Christ's sacrificial death on the cross into the church (crucified savior).
- 3. **Descending Dove**... Expresses innocence and humility and purity. It signifies the Holy Spirit and the presence of God and Jesus at his Baptism.
- 4. **Circle**.....Eternal, because it is without beginning and without end, everlasting life.
- 5. **Open Bible**.....Symbolizes the word of God, eternal truth, the great plan of life.

That whosoever will believe in God, Son and Holy Spirit, and that Christ was crucified and He is our salvation and being Baptized with the Holy Spirit, believing in the word the eternal truth can be saved, we will have everlasting life.

### PROCEEDINGS 2006 OCTOBER 6, 2006 FRIDAY MORNING 10:00 A.M.

The 94<sup>th</sup> annual session of the General Association of Separate Baptists in Christ convened with the Central Indiana Association at their campgrounds in Fruitdale, IN. The session was opened with Moderator Rev. Jimmy Polston asking Bro. Rick Goff of the Nolynn Association to lead the congregation in singing, "That Glad Reunion Day". Bro. Randy Polston of the Central Indiana Association played the piano.

The body was called to order by the Moderator, Rev. Jimmy Polston.

We observed a moment of silence in prayer for our service personnel.

Rev. Polston then led the congregation in pledges to the American and Christian Flags, and the Bible.

Rev. Melvin Underwood of the Nolynn Association, came with the invocation reading the 133<sup>rd</sup> Psalm. Prayer requests were called for. Rev. Jim Goff of the Nolynn Association led the prayer.

Bro. James White of the Nolynn Association asked a blessing upon the service this morning.

The Moderator then asked for a unanimous consent to elect an assistant moderator to replace Bro. Joshua Peak. Bro Rick Goff was nominated. Motion was made and properly supported that nominations cease. Motion carried.

The Moderator then asked for a unanimous consent to elect an assistant clerk to serve in Bro. Matt Cowan's absence.

Rev. Mark Polston was nominated. Motion was made and properly supported that nominations cease. Motion carried.

The letters were read from the following district associations: **CENTRAL INDIANA, CHRISTIAN UNITY, MT. OLIVE, and NOLYNN.** A motion was made and properly supported to receive the letters and to seat the appointed delegates, and any delegates that arrive later in council and print the letters in the minutes. The motion passed and the delegates were seated in council.

By unanimous consent the Moderator appointed Rev. Danny Bailey of the South Kentucky Association to serve as Parliamentarian for this setting of the Association.

The Articles of Doctrine were then read by the clerk.

A call for new association(s) was made. None responded. Bro. Rick Goff of the Nolynn Association asked the blessing on the congregational offering for the Association expenses. The congregation sang "What A Day That Will Be," as an offering totaling \$248 was received.

The body then convened at the altar for prayer led by Rev. Jim Hale of the Nolynn Association.

Rev. John Perkins of the Central Indiana Association came to deliver the Introductory Sermon. He read Ezekiel 3:17-21,

using as his text a portion of verse 17, "Son of man, I have made thee a watchman". Bro Johnny said that when others learn he is a preacher the first question they ask is whether he serves "full time". He said that everyone that is a Christian, whatever his position, is serving full time. We must "work while it is day, for the night cometh when no man can work" and be diligent doing the Lord's business because the world is dying lost. Often those who work in the church, preachers, deacons and Sunday school teachers, feel they are carrying all the responsibility of the church, but we should remember the work must be done. There is no place for us to give up or even slow down. Bro. Johnny reminded us of the parable of the shepherd who left his flock of ninety and nine sheep to search for the one lost sheep. We need the attitude of Isaiah. When he heard the Lord ask, "Whom shall I send, and who will go for us"? He responded, "Here am I; send me". We should ask the Lord to give us a burden for those who are lost. The souls of mankind are precious to God, we should have a great concern for them and weep for them before people, before they die lost.

The congregation sang "I'll Meet You In The Morning" as the saints fellowshipped around the altar with a handshake.

Without objection the Moderator appointed the Divine Service Committee to choose a second and third alternate to fill vacancies for this afternoon's five minute talk on False Doctrine. The committee appointed Rev. Ransom Covington as the second alternate and Rev. Danny Bailey as the third alternate. The body voted to accept these appointments. After several announcements and testimonies, Bro. David Barr of the Christian Unity Association prayed the benediction and Bro. Danny Cave of the Central Indiana Association asked the blessing on the afternoon meal.

### **FRIDAY AFTERNOON 1:30**

The Friday afternoon service was opened with Bro. David Barr of the Christian Unity Association, leading the congregation in singing "Jesus Is Coming Soon", Sis. Janet Barr also of the Christian Unity Association played the piano.

Rev. James Hale of the Nolynn Association had charge of the afternoon devotional reading Matthew 23:37-39. After prayer requests were made the saints joined in prayer led by Rev. Steve Palmer of the Central Indiana Association.

The assistant clerk read the minutes of the morning session. A motion was made and properly supported to accept the minutes with any necessary corrections and additions and print them in book form. The motion carried.

### **UNFINISHED BUSINESS:**

The motion tabled at last year's Association to change the pledge of the Christian Flag, listed in the back of the General Association Minute book, to the version used by the Nolynn Association came before the body. After discussion, the motion failed.

### **NEW BUSINESS:**

Bro. Noah Vance and Bro Charles E. Jordan, Sr. both of the Nolynn Association moved the Moderator appoint a committee to research and contact groups that believe like we do. The motion carried. The Moderator appointed Bro. Michael Jordan of the Nolynn Association as the Chairman serving with Rev. Danny Bailey of the South Kentucky Association and Rev. Mark Polston of the Central Indiana Association.

Bro. Rick Goff and Bro. Charles E. Jordan, Sr. both of the Nolynn Association moved that SBMI put together a Directory of all churches currently in the Association similar to the one published several years age. This directory should contain a picture of each church, a short history, church meeting times, listing of church officials, directions to the church, and any other pertinent information such as deemed necessary by the SBMI Board. Orders for the directory should be taken in advance with prices in line to cover printing costs. There should be enough spare directories printed to allow for additional sales and distribution to other interested parties. This same information when gathered, can be used to update/complete our separatebaptist.org web site. Following discussion, motion carried.

The Separate Baptist Missions, Inc. Treasurer's Report for Home & Foreign missions was given by Bro. Jimmie McGaha, SBMI Treasurer.

#### FIVE MINUTE TALKS

#### **Alcohol and Drug Abuse:**

Rev. Jerry Ridge of the Central Indiana Association read Proverbs 23:29-35. The use and abuse of alcohol and drugs has caused so much heartache in people's lives. Rev. Ridge used the opportunity to send out warnings to get hold of our loved ones before they venture down these roads. Users of alcohol and drugs will make children feel welcome and be a friend to them. When children turn away from their families and people they've known for years, it is a sign to get hold of your children. One drug leads to another drug that is worse. When addicted, they will sell or trade everything to get drugs. They destroy lives. Users are looking to fill up what is missing in their lives; we know that's Christ, but they are looking and they try to fill it with drugs. Alcohol and drugs will steal their natural affection. Everyone is susceptible, we must keep watch. Alcohol and drugs destroy lives, but prayer works. Nobody gets off drugs and alcohol until they want to, they will not want to until we stop paying for it. There is hope through prayer!

### **Sunday School Purpose:**

Bro. Jimmie McGaha of the Central Indiana Association spoke about points presented by the teachers at the Edinburgh Church. Sunday school helps everyone learn at their own level and gets us in the habit of reading and studying the Bible. It challenges us, provides us a set time to study the word, gives us opportunities to ask questions about things we do not understand. Close friendships can be developed and Sunday school can be a great outreach to the community. Using the term "I've not had this much fun since the pigs ate my little brother" was how one described their excitement about attending Sunday school. We <u>should</u> be enthusiastic about God. Sunday school leaves a lasting impression on us. What are we doing now in support of Sunday school? Can we do more?

### God's Instruction on Family Relationships:

Rev. Melvin Underwood of the Nolynn Association read Matthew 19:1-6 and Ephesians 5:22-28. Emphasizing this is the foundation of a good family. Reading Ephesians 6:1-4, he reminds us that we teach by our examples. We find the right advice in the Word of God, and with prayer between us and God. We teach by our daily life. The number one priority needs to be God, not just in our lives but also in our families. Rev. Underwood reminds us we teach by example, using the as an example the prodigal son. We need not be slack about the things of the Lord.

#### False Doctrine (It's Effect on Our Churches):

Rev. Ransom Covington of the Central Indiana Association read Hebrews 13:9, II Timothy 4:3 & 4, Isaiah 32:5 & 6 and II Peter 2:1-3. It is so important to know what you believe, because it is easy to be led astray by false doctrine. The dangers include witchcraft, which is forbidden in the scriptures. Our mere fascination with these will bring the wrath of God upon people. The ill effect of things like "seed money" and other sensationalism will take our focus off of God. Our people will be enamored and become dismayed. "A little leaven leaveneth the whole lump". If it comes in among us, it will split us wide open, destroy our faith and come between us. Some false doctrines have good points, but the end result is damaging, resulting in eternal damnation. The ill effects of false doctrines deceive people who hear their teachings. It is imperative we take a stand or we're going to fall. If you're a young Christian, stay away from television teachers; read your Bible and pray. You can't jump up everyday, throw on your clothes, live your life and realize a week has gone by without reading your Bible. We make time for our priorities.

Rev. Ed Tharpe of the Central Indiana Association asked the blessing on the offering, the congregation sang "O How I Love Jesus" as the offering of \$168 was collected.

Rev. Johnny Davis of the South Kentucky Association came to deliver the afternoon sermon, reading John 11:21 & 22. Galatians 3:15-29 & 4:1-6. We stood for prayer led by Rev. Lonzo Wiggington of the Central Indiana Association. Rev. Davis took his text from verse 4 in the 4<sup>th</sup> chapter of Galatians, focusing on "timing is everything". There is a time to be born. Above everything else, there is a time to be born again. We never need to put off salvation. The time to answer is when God is calling. You can tell when people are in time with the Lord by just listening to them. Occasionally people need a little adjusting, just like a machine that gets out of time. God is the one who can adjust people. It's wonderful when the church and people are in time with God. God knows how to get everything working if we'll just do our part. Jesus said, "If I will that he tarry till I come, what is that to thee"? "In your presence, possess ye your souls". When we don't wait on God, we get in trouble. God's ways are higher than the things on Earth.

It takes God's timing to do the work of the Lord, sow the seed in God's time and he'll send the water and give the increase. The time to preach is when God leads. If we don't sow, we won't reap. Be not deceived, God is not mocked, whatsoever a man sows that shall he also reap. God knows how and when a child develops in a mother's womb. In the fullness of time, God sent forth his son. God's timing was not off when he sent his son, it was perfect timing. Rev. Davis used the birth of Christ and the sequence of events surrounding his birth as an example of the importance of being in God's timing.

A lot of time, people's timing gets off. Today is the day of salvation. It's not when death comes, its not when marriages split, it's not in a thousand years. We need to let God do the ordering and follow it. Let's bind together in unity and harmony and keep in time.

There are those who do not understand what is being preached to them. When we handle the Word of the Lord the way we are supposed to there are those who will despise us. If our focus is on something new and different instead of the Lord, we are in trouble. When we focus on Charismatic things in the church, we are taking the focus off the Lord. It takes the place of being in a closer communion with the Lord. We need to be careful that our focus stays on the Lord. The doctrine is tried and true. We need to be honest, faithful and true to the Lord.

Rev. Polston referred to the scripture in Jeremiah were the Lord asked, to whom shall I speak? Reminding us to stand in the ways and ask for the old paths. The only thing a man of God will preach is the Word of God. We have to follow after the Lord says. Our focus needs to be on God and not necessarily on the local church. We are not alone, when we stand on the Word, God will give the increase.

### BY-LAWS OF SEPARATE BAPTIST MISSIONS, INC. UNDER THE GENERAL ASSOCIATION OF SEPARATE BAPTISTS

### Separate Baptist Missions, Inc.

Separate Baptist Missions, Incorporated shall be a religious non-profit incorporation for the establishment, furtherance and overseeing of Separate Baptist home and foreign missionary enterprises. The Incorporation shall be established in accordance with the laws of the state of Kentucky and shall be registered to conduct its lawful affairs and privileges in each state, either represented by an established Separate Baptist Church or represented for the establishment of a new Separate Baptist Church in fellowship with the General Association of Separate Baptists in Christ (hereafter referred to as the General Association).

Separate Baptist Missions, Incorporated shall consist of a board of three members who are elected for three-year terms by the General Association and of associational directors who will be elected or appointed to yearly terms by the District Associations. It shall be the duty of this board, in-as-much as possible, to carry out the desires of the General Association in all mission matters.

Separate Baptist Missions, Incorporated shall be governed with the by-laws established and approved by the General Association. The by-laws may be altered or amended at any General Association by a two-thirds majority vote of the voting delegates. No by-law, established or amended, shall knowingly violate the law(s) of the states under which this incorporation is registered.

Should this incorporation ever be dissolved, all records, monies and properties held by the incorporation at the time of dissolvement shall be turned over to the General Association for disbursement as the General Association may deem necessary and proper.

### BY-LAWS OF SEPARATE BAPTIST MISSIONS INCORPORATED Section One The Board

1. Separate Baptist Missions, Inc. shall have a board consisting of a chairman, a secretary, a treasurer, and associational directors. Each board member shall assume his responsibilities upon his election or appointment to office and shall serve in said office until his successor is elected or appointed. The board members shall obtain office and serve terms of duration as follows.

- A. The chairman of this board shall be elected by the General Association for a term of three years duration.
- B. The treasurer of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the chairman's term.
- C. The secretary of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the treasurer's term.
- D. The associational directors of this board shall be elected by the District associations for a term of one year duration. They shall be elected yearly. There shall be one associational director elected from each District association.
- 2. All members of the board and personnel serving under the board must be Separate Baptist personnel.
- 3. A board member may be re-elected or re-appointed to successive terms.
- 4. The board of Separate Baptist Missions, Inc. shall meet at least once during every associational year other than at the General Association. They may also meet on assent of the board members when and as necessary. Written notices stating the time, date, location and purpose of each special board meeting shall be sent in advance to each board member.
- 5. A Quorum of five board members shall be required to transact official board business.

6. All board members shall serve without pay or reimbursement from mission funds \*

(with the exception of the treasurer and the secretary-treasurer who may be reimbursed from the Home Missions fund as deemed proper by the board).

\* Changed October 12, 1991 at the General Association.

## Section Two Funds and Property

- 1. All funds are to be received on a voluntary manner and no church or District association shall ever be assessed for mission funds.
- 2. The treasurer of the board shall keep a permanent record of all receipts and expenditures and shall present a written yearly financial report to the general Association.
  - A. The treasurer's books are to be audited yearly at the General Association by the Auditing Committee.
  - B. The treasurer shall be bonded and said bond shall be paid for as general operating expenses.
- 3. Separate accounts and records shall be kept for home and foreign missions funds.
  - A. All undesignated funds received by the treasurer shall be subject to the discretion of the mission board, for either home or foreign mission purposes.
  - B. All funds received designated for a particular purpose shall be used entirely for such designated purpose. If such funds cannot be used for its designated purpose, they shall be returned to their donor and an explanation given as to why they could not be used.
  - C. A tax-exempt receipt shall be given upon request for all gifts and donations.
- 4. All general operating expenses of the board shall be paid for from the home mission fund.
- 5. The board shall have the authority to withdraw and use funds from their respective accounts for either home or foreign missionary projects.

- A. Grants or loans cannot be made to any individual for personal use.
- B. Grants or loans may be made for worthwhile purposes to District associations or churches which may request such aid.
- C.\* Grant amounts given to any one church will be determined by the board. \*October 9, 1999, was changed at General Association from \$500/yr to any one church within an associational year
- D.\* Loans may not exceed in the amount of one thousand (\$1,000) dollars and are to be repaid within a period designated at the time of said loan, but not to exceed five years. No interest shall be charged for money loaned. \*October 8, 1988, was changed at General Association to \$2,000.
- E. A minimum of \$5,000.00 emergency fund will be maintained in the Foreign Mission Treasury.
- 6. All property purchased through the mission board for the establishment of a Separate Baptist Church shall be deeded to the trustees and their successors of the District association in which the church is established. (In event that the District association does not have trustees to which the property may be deeded, it shall remain deeded to Separate Baptist Missions, Inc.)
- 7. All property purchased on the foreign field in behalf of Separate Baptist Missions, Inc. shall remain, where possible, the property of Separate Baptist Missions, Inc.

## Section Three Missionary Personnel

- 1. All missionaries serving under this board shall preach and teach according to the doctrinal statement of the General Association of Separate Baptist Churches.
- 2. All missionary candidates shall be examined by the board in regards to doctrinal, spiritual and mental requirements and shall furnish a doctor's statement on their physical condition.
- 3. All missionary candidates must do their deputation work with the mission board only assisting.

- 4. All missionaries shall serve pre-designated terms on the mission field and must spend a proportionate amount of time while on furlough in the states reporting to the churches which contributed to their support.
- 5. All missionaries must send regular monthly reports to the board concerning their work and progress while on the field.

## CONSTITUTION

**ARTICLE 1**. This body shall be called "The General Association of Separate Baptists in Christ" and shall be composed of ministers, deacons and delegates of the various District Associations and their several churches.

**ARTICLE 2.** Officers of this body shall be: Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, who shall be elected by this body and shall hold office one year or until their successors are elected, and shall serve free, except the Clerk, who shall be paid \$200.00 for his services by the Association.

**ARTICLE 3.** Duty of the moderator shall be: Preside at all meetings, appoint all committees and cast the deciding vote in the case of a tie. Duties of the Assistant Moderator shall be the same as the Moderator in case of his absence. The Clerk shall make complete Minutes of the proceedings of the Association, inserting in the Minutes the name and addresses of the ministers and church Clerks. The Clerk shall make completed minute books available to the churches no later than March 1 of each associational year if at all possible. The Assistant Clerk shall do the duties of the Clerk in his absence and assist the Clerk at any time he may need him. The Treasurer shall receive and pay out money and make a report at each meeting. No person shall hold more than one elected office in this organization. It shall be the duty of each District Association to contribute \$25.00 or more to the support of this body.

**ARTICLE 4.** The object of this body shall be to bring about a closer union and give united effort in putting forth the Word of Life.

**ARTICLE 5**. This Association thus formed shall be a council of advice and shall not exercise any undue authority over God's heritage. Each Association composing this body shall be entitled to three delegates from each church.

**ARTICLE 6.** This Association shall be governed by parliamentary rules.

**ARTICLE 7.** Any person wishing to address the body shall rise and address the Moderator.

**ARTICLE 8.** This body shall have a Mission Board which shall be authorized to oversee the Home and Foreign Mission aspects of our General Association. The said Mission Board shall be governed by the Rules and Regulations set forth by the General Association. Such Rules and Regulations shall become a part of our General Association Constitution.

**ARTICLE 9.** Any Association belonging to this Association failing to report at each annual meeting, the Moderator shall appoint a committee to investigate why they did not report.

**ARTICLE 10.** Any Association applying for membership in this body shall be required to give evidence of its orthodoxy and shall agree to comply with the rules before being received into this body.

**ARTICLE 11.** This Constitution, By-Laws or Articles of Doctrine, may be changed or amended by a two-thirds vote\* of the body at any regular session, after having been tabled for a period of one associational year. Any changes that are to be made in the Constitution will be presented to the Constitution Committee prior to its submission to this body. The Constitution Committee shall consist of one member from each district association. The Moderator shall appoint a member to the Constitution Committee from each district association. Should the committee be required to convene to act upon any proposal and the appointed member be absent, the General Association's Moderator shall name a replacement. • Pursuant to action taken at the 1991 General Association "two-thirds vote" was defined as: "two-thirds of those who vote on that particular motion.

**ARTICLE 12.** The Pledges to American and Christian Flags and the Bible to be conducted by the Moderator at each morning session, prior to invocation and/or devotion.

### **BY-LAWS**

1. The Association or Church entertaining the General Association shall be given the privilege of setting the beginning time of each session to be held in that Association or Church and the entertaining Association or Church shall advise the Program Committee for the session about the starting time before the Program Committee reports to the body.

2. There shall not be anyone placed on a program or a committee that is not present at that session of the General Association.

3. Each District Association shall be responsible to list the names of all delegates and alternates from each church appointed to represent them at the General Association in or with their respective letter to the General Association. The delegates and alternates listed on or with the letter for the District Associations will be the only recognized appointed delegates to the General Association.

### **ARTICLES OF DOCTRINE**

**ARTICLE 1.** We believe that the Scriptures of the Old and New Testament are the infallible Word of God, and the only safe rule of faith and practice, using the King James version of the Holy Bible for English-speaking people (\*see below). ROM. 15:4, 1st COR. 10:11. 2nd TIM. 3:16-17, GEN. 1:1 through REV. 22:21.

**ARTICLE 2.** We believe that there is in the God Head three Divine Personages: The Father, The Son and The Holy Spirit. MATT. 28:19, 1st COR. 12:3, 1st TIM. 2:5, HEB. 1, 1st JOHN 5:7.

**ARTICLE 3.** We believe that man is in a fallen state before God and is unable to liberate himself by any ability he may possess by nature. ISAIAH 63:1-5, JOHN 6:44, 14:6, ROM. 8:1-20, 1st COR. 15:22.

**ARTICLE 4.** We believe that salvation, regeneration, sanctification, justification and redemption are through faith in the life, death and resurrection, ascension and intercession of our Lord and Saviour Jesus Christ. JOHN 17:13-17, HEB. 4:1-3, EPH. 4:1-8, TITUS 3:3-7, REV. 1:18.

**ARTICLE 5.** We believe that he who endures to the end, the same shall be saved. MATT. 10:22, 24:13, HEB. 3:12, 10:38-39, REV. 2:10.

**ARTICLE 6.** We believe in the resurrection of the body, the just and the unjust, but every man in his own order, those who have done good, to eternal life, those who have done evil, to eternal damnation and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. DANIEL 12:2, MATT. 25:46, ROM. 5:21.

**ARTICLE 7.** We believe that the joys of the righteous and the punishment of the wicked are eternal. DANIEL 12:2, MATT. 25:46, ROM. 5:21.

**ARTICLE 8.** We believe that Baptism, the Lord's Supper and feet washing are ordained of Christ appointed in the Church and none but true believers are proper subjects, and that immersion is the Gospel mode of baptism. MATT. 28:19-20, LUKE 22:17-20, JOHN 13:14, ACTS 2:41, ROM. 6:4, COL. 2:12. **ARTICLE 9.** We believe in the sanctity of the first day of the week, or Lord's Day, and it should be spent in public or private worship, and we abstain from worldly concerns, except in case of necessity or mercy. LUKE 23:56, JOHN 20:26, ACTS 20:7, 1st COR. 16:2, REV. 1:10.

**ARTICLE 10.** We believe it is our duty to be tender, affectionate to one another, in honor preferring one another, to study the happiness of God's people in general and do all we can to support, promote and spread the Gospel. ISAIAH 53:1-10, ROM. 12:10, GAL. 6:1-2, 10, 2nd COR. 9:14.

**ARTICLE 11.** We believe that Jesus Christ, by the Grace of God tasted death for everyman, that none can partake of His Holy Divine benefits except by repentance toward God and Faith in the Lord Jesus Christ; Infants and the innocent, due to lack of mental ability excepted, they being included in the covenant of God's Grace. MATT. 9:13, LUKE 18:15-18, JOHN 3:15-17, ACTS 4:12, ROM. 5:15, 1st TIM. 2:5-6.

**ARTICLE 12.** We believe that, at Christ's coming in the clouds of Heaven, all Christians will be gathered with Him in the clouds and that time shall be no more, thus leaving no time for a literal one thousand year reign. MATT. 24:29-31. REV. 10:6, 1 THESS. 4:15-18, 2 PET. 3:10.

\*We believe that non-English speaking people should use a Bible comparable to the King James Version of the Holy Bible.
