



## OCTOBER 12, 2007 FRIDAY MORNING 10:00 A.M.

The 95<sup>th</sup> annual session of the General Association of Separate Baptists in Christ convened with the Christian Unity Association at the Pleasant View Church in Warrensville, NC. The session was opened with Moderator Rev. Jimmy Polston asking Bro. Scott Polston of the South Kentucky Association to lead the congregation in singing, "I'll Meet You By the River" and "Just a Little Talk with Jesus". Bro. Randy Polston of the Central Indiana Association played the piano and Bro. Jordan Polston of the Central Indiana Association played the guitar.

The body was called to order by the Moderator, Rev. Jimmy Polston.

We observed a moment of silence in prayer for our service personnel followed by a prayer led by Rev. Polston.

Rev. Polston then led the congregation in pledges to the American and Christian Flags, and the Bible.

A call for new association(s) was made. None responded. Rev. Jim Tharpe of the Central Indiana Association asked the blessing on the congregational offering for Association expenses. The congregation sang "Everybody Will Be Happy Over There," as an offering totaling \$285 was received.

Rev. Jim Mason of the South Kentucky Association came to deliver the Introductory Sermon. He read the 3<sup>rd</sup> chapter of Philippians, using as his text "Footsteps of Paul". Rev. Mason focused on the things Paul experiences; beginning with Paul on the road to Damascus. Rev. Mason read Romans 8:1. Many people today have gone in the wrong direction because their mind is not on the Lord. We need a different attitude toward what we're doing for the Lord. Sometimes we're afraid to tell who we are; we need to go just a little bit farther. We need to be proud of whom we are and what the Lord has done for us. We never get too old to do what the Lord has called us to do.

Paul had a testimony and a vision. Rev. Mason recounted Paul's defense reminding "he was not disobedient to the Heavenly vision." Paul used his imprisonment to further the work of the Lord. We need to have the vision. Rev. Mason used his testimony "I have kept the faith," reminding us of Paul's faith. He reminds us it is impossible to do the Lord's work without faith. We need to exercise our faith. What's wrong with most people today, "they are not walking in the spirit," and "if you have not the spirit you're none of his."

Paul was a praying man. "A lot of the times we are not praying the way we should." Rev. Mason shared his own disobedience when he had to repent because he did not heed the Lord's vision and how he went back to the road of Damascus and committed himself to doing the Lord's work again. We need to be a good example for the others coming up. Paul was a good example before all his people; he had love, he had faith.

If we are a good example and follow in the Lord's path; there is healing in our shadows, just as there was in Paul's shadow. Paul said "walk after me as I follow Christ."

The congregation sang "Won't It Be Wonderful There," "I'll Live in Glory," & "I'll Fly Away" as the Saints fellowshipped around the altar shaking hands.

#### FIVE MINUTE TALKS

#### **Alcohol and Drug Abuse:**

Rev. Matt Cowan of the South Kentucky Association read Isaiah 28:1-4. Bro. Matt urged us not to see alcohol and drugs as a problem that is "outside" the church. Share with the youth and the entire church, discussions on the subject. Let everyone know that we can address the issues of sin as a church to help detour the paths of evil. What does the Bible say concerning these issues? Focus on the person not the problem they have. Care for the soul and try to win that soul to the Lord. **Sunday School Purpose:** 

Bro. Lee Bertram of the Mount Olive Association read Deuteronomy 31:13 and Romans 15:4 emphasizing the time to start is when they are young. Reading Isaiah 1:17 we need to learn to do well. The Sunday School is a guiding hand to help the children become what they need to be. Reading Titus 3:14 and Matthew 11:29-30; Sunday School teaches children that serving God is easy when we follow his word.

#### God's Instruction on Family Relationships:

Rev. Mark Polston of Central Indiana read Colossians 3:18-22 and Ephesians 6:1-4 reading God's instruction for the family. God instructs us to be one man, one woman bound by God in marriage for life. Ministers, pay close attention to not being unequally yoked.

#### **False Doctrine:**

Rev. Danny Bailey read II Timothy 4:2-4; I Timothy 4:1-4; and II Timothy 2:15-16, stating these versus remind him of the church today. False doctrine picks and chooses how it interprets scripture. In order to combat false doctrine, look at scripture for what it really has to say; be consistent in its interpretation. The Bible is what it is.

Rev. Matthew Dalton of the South Kentucky Association came to deliver the afternoon sermon, reading Luke 24:1-29. Rev. Dalton focused on "idle words," preaching "Set Up and Pay Attention." God has different ways of getting people's attention. There comes a time when we must realize the Bible is not idle words. When you get to loving God with all you've got; it goes deep. We must do the same thing, for the Lord to descend upon us. God will take care of his people if we'll hold to what's good, what we need to hold on to. Rev. Dalton read Philippians 2:1-2. God requires us to be in one accord, one mind. This is not a time to be sleeping or goofing off in the things about God. We need to be paying attention to God and what he said. Just as the people heard what Noah had said once the door was shut. God is really speaking to his people. He has so much for us; we can never begin to understand what God has done for us.

evening devotional reading verses 12 through 14 of the 116 <sup>th</sup> Psalm. The
congregation gathered around the altar for prayer led by Rev. Jerry Ridge
of Central Indiana Association.
The minutes of the Friday afternoon session were read and
accepted with the necessary additions or corrections.
Rev. Jimmy Polson of the Central Indiana Association read
Daniel 2:31-45, 9:20-27; Hebrews 12:18-29. Rev. Polston took verse 28
of the twelfth chapter of Hebrews as his text. "Wherefore we receiving a
kingdom which cannot be moved, let us have grace, whereby we may
serve God acceptably with reverence and godly fear:"There will be a
payday coming for us because we have tried to change the culture of
Christians. This is the devil's way of working. God is working in the
affairs of nations, he is in control; and he still has created us free moral

agents. We are the ones to be praying 'thy kingdom come thy will be done.'

Rev. Polston used Daniel's prophecy of King Nebuchadnezzar's dream as the illustration of God's ability to understand and signify the rebuilding of the never-ending Kingdom. The Kingdom is here and now and is never ending, and within you. He used the parable of the wheat and the tares to illustrate how the unbelievers exist in the world and grow amongst the Christians but will be separated in the last day. Christ was not surprised when Judas kissed him to give him away. How great is Christ's love to be able to love even knowing Judas was going to betray him. Daniel prophesized, John preached and Jesus preached of the kingdom that came with Jesus Christ. The Father ordained Christ following his baptism by John the Baptist, when the heavens opened and a dove came down, saying 'this is my beloved son in whom I am well pleased."

Jesus said "a man cannot see the kingdom of God, except he be born again." The kind of kingdom you can behold is by faith not like David set up; but a spiritual one, a greater one, set up by Christ, the eternal son of God, from the beginning of the world.

When Jesus died on the cross of Calvary that ended the other sacrifices of the Jewish people; any sacrifices made unto God other than Christ are an abomination. The Kingdom should be without end. There is no other mediator other than Christ. Christ is reigning in the hearts of those in his Kingdom, even among the tares. The Kingdom of God is not in word, but in power. The twelve apostles bear witness of what they saw and heard of Christ's Kingdom. God humbles himself to look upon the heavens. Because God wanted to, he reveals some things about himself.

Part of the Church has gone on, part are still here. For by one spirit we are all born into one body, the Lord's Jesus Christ. Present your bodies a living sacrifice, not conform unto this world. We have a better Priest, a better Offering than they had before which cannot be shaken and cannot be moved.

At the conclusion of the sermon, the congregation stood and sang "Let's Just Praise the Lord"

Bro. Jimmie McGaha of the Central Indiana Association led the congregation through the communion and feet washing service reading Luke 22: 7-8; 13-14; and 19-20. Bro. Benny Walden of the Central Indiana Association asked the blessing on the bread. The body was served the bread and all took together. Bro. Mike Hardwick of the Central Indiana Association asked the blessing on the cup. The deacons then served the cup and everyone took together. Bro. McGaha then read John 13:4-5 and 12-17. The men and women separated and at the instruction of Bro. McGaha, washed feet.

There were 81 taking part in the service. The congregation worshipped the Lord with praises, songs, and shouting during and following the feet washing.

Rev. Melvin Underwood of the Nolynn Association led the congregation in the memorial prayer.

Rev. Danny Bailey, SBMI Chairman came and updated us on the activities at home and in the Ivory Coast. Rev. Jerry Ridge updated us on the purchase of land in Abidjan to build a church.

Rev. Bailey then introduced the Mission Board's choice to deliver the Mission sermon, Rev. Lonnie Palmer.

Rev. Palmer talked about the women whose price is above rubies reading Proverbs 21:9 and 31:10. The only place where women are equal to men is Christianity. Women that are Muslims are stupid; they only want to please men. Women have an exalted place in Christianity. Having the spirit is having self-control. A Christian would not let their daughter be on a high school dance team. We should not denounce women movements just because "some" are ungodly. Women suffer whatever their husbands suffer.

Some women in the Bible were prophetesses. When men are not doing the job, women have to do it. Women in their ministry in the New Testament ministered unto the Lord and the apostles. The women were the ones crying and bemoaning the crucifixion of the Lord. Women were the first at his resurrection, while the men were hiding from the Jews. Women were the first to announce the glad tidings of Christ's resurrection.

Women were not called apostles, but they were just as important as the apostles. When Paul established the church at Philippi, he stayed at Lydia's house. If you have a vision for your church and the Lord, you will not lose your church. Rev. Palmer stated he would like to see our ladies organize the mission work in our churches. When the spirit is missing, all you have is an empty sack. Missions are a commandment of God.

The clerk announced the next scheduled General Association held with the Christian Unity Association would be the 100<sup>th</sup>.

Rev. Danny Bailey of the South Kentucky Association came to deliver the afternoon sermon, reading I Corinthians 16:5-9. Rev. Bailey focused on verse 9. Even though Paul wanted to go to Corinth, he stayed at Ephesus because of the "great door" there. We, as Separate Baptists, have a great door. The door of opportunity is not always open. If we're not faithful in the little things; God will not hand us the bigger. How many souls have we turned our back on because we're not reaching out? If we have the greatest message ever told; we've got to stop not sharing it. We're starving and dying because we won't get up from the condition we're in. Why sit we here until we die?

Jesus never said he was going to send us sinners. We need to go out and get them. We need to take back that zeal and fire we've experienced here to our churches. #### **OUTREACH COMMITTEE**

We the Outreach Committee were appointed by the moderator to investigate ways for the General Association to contact churches with which we have common belief. We the Outreach Committee have found 10 churches, 15 Associations and 1 Mission who all have been called Separate Baptist at some time with in the last 140 years. We found these churches after much research on the Internet and through the use of past minute books. Because the addresses of churches are often not listed in Separate Baptist minute books, most of the locations were found from searches on the Internet. The churches found were mostly located in the states of Iowa, Nebraska, Illinois, Kentucky, Missouri, Indiana, Tennessee, Alabama and Georgia. One Separate Baptist Mission was found outside of the U.S. The "Separate Baptist in Christ India Mission" was founded in 1917. It is located in Ahmednager district India and has 3 churches with 4,000 total members.

On October 4 I, (Michael Jordan) attended the General Association of the Baptist which was in Association at the New Hope Baptist Church in Manchester Tennessee. There was a great worship service in the old time "Separate Baptist Style" with many amen's, shouting and the Spirit of the Lord could be felt by all who were there. Here I learned more about "The Baptist" and their "Articles of Faith" which are a little different than ours. But the majority of their Articles are in alignment with ours. The Outreach Committee gave the General Association a letter expressing a desire for correspondence. The General Association of The Baptist accepted the letter, saying that they would send a letter of correspondence, some minute books and maybe a visiting messenger to the General Association of Separate Baptist. I told the whole General Association of The Baptist, that if they are in Kentucky, Indiana, North Carolina, West Virginia or the Northern part of Tennessee, they are welcome to attend the churches of the General Association. They are also invited to attend the General Association of Separate Baptist when it meets on October 12 and 13, 2007.

On August 18, 2007 the Outreach Committee attended the Duck River Association of Baptist. There was a good service there with heart felt preaching. There, I relayed a letter from the Outreach Committee expressing a desire for correspondence. It was received. The Duck River Association said they would send a letter of correspondence, some minute books and maybe a visiting messenger to the General.

Any Church that would like to welcome members of these churches to attend future special services like Homecoming, Communion and Feetwashing, Revivals, etc., can send a notice to the churches. The Outreach Committee could help you find the addresses of the churches of the General and Duck River Association.

The next group of churches the Committee plans to contact will be churches in Georgia that, able historians have termed Separate Baptists. They are described as "often rural in their orientation, they favor temperance, feetwashing, theologically untrained ministers, and associational missions". For the most part, they focus on worship, mutual encouragement, and localized benevolences. Eight associations of this variety existed in 2002, containing an estimated 128 churches with 20,304 members.

The Outreach Committee is also requesting 100 minute books of the General Association. These minute books will be given out as we visit the eight associations in Georgia. If anybody would like to help in the research, please contact the Outreach Committee at the address listed for the Outreach Committee.

### BY-LAWS OF SEPARATE BAPTIST MISSIONS, INC. UNDER THE GENERAL ASSOCIATION OF SEPARATE BAPTISTS

#### Separate Baptist Missions, Inc.

Separate Baptist Missions, Incorporated shall be a religious nonprofit incorporation for the establishment, furtherance and overseeing of Separate Baptist home and foreign missionary enterprises. The Incorporation shall be established in accordance with the laws of the state of Kentucky and shall be registered to conduct its lawful affairs and privileges in each state, either represented by an established Separate Baptist Church or represented for the establishment of a new Separate Baptist Church in fellowship with the General Association of Separate Baptists in Christ (hereafter referred to as the General Association).

Separate Baptist Missions, Incorporated shall consist of a board of three members who are elected for three-year terms by the General Association and of associational directors who will be elected or appointed to yearly terms by the District Associations. It shall be the duty of this board, in-as-much as possible, to carry out the desires of the General Association in all mission matters.

Separate Baptist Missions, Incorporated shall be governed with the by-laws established and approved by the General Association. The by-laws may be altered or amended at any General Association by a twothirds majority vote of the voting delegates. No by-law, established or amended, shall knowingly violate the law(s) of the states under which this incorporation is registered.

Should this incorporation ever be dissolved, all records, monies and properties held by the incorporation at the time of dissolvement shall be turned over to the General Association for disbursement as the General Association may deem necessary and proper.

# BY-LAWS OF SEPARATE BAPTIST MISSIONS INCORPORATED Section One The Board

1. Separate Baptist Missions, Inc. shall have a board consisting of a chairman, a secretary, a treasurer, and associational directors. Each board member shall assume his responsibilities upon his election or appointment to office and shall serve in said office until his successor is elected or appointed. The board members shall obtain office and serve terms of duration as follows.

- A. The chairman of this board shall be elected by the General Association for a term of three years duration.
- B. The treasurer of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the chairman's term.
- C. The secretary of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the treasurer's term.
- D. The associational directors of this board shall be elected by the District associations for a term of one year duration. They shall be elected yearly. There shall be one associational director elected from each District association.
- 2. All members of the board and personnel serving under the board must be Separate Baptist personnel.
- 3. A board member may be re-elected or re-appointed to successive terms.
- 4. The board of Separate Baptist Missions, Inc. shall meet at least once during every associational year other than at the General Association. They may also meet on assent of the board members when and as necessary. Written notices stating the time, date, location and purpose of each special board meeting shall be sent in advance to each board member.
- 5. A Quorum of five board members shall be required to transact official board business.
- 6. All board members shall serve without pay or reimbursement from mission funds \*

(With the exception of the treasurer and the secretary who may be reimbursed from the Home Missions fund as deemed proper by the board).

\* Changed October 12, 1991 at the General Association.

# Section Two Funds and Property

- 1. All funds are to be received on a voluntary manner and no church or District association shall ever be assessed for mission funds.
- 2. The treasurer of the board shall keep a permanent record of all receipts and expenditures and shall present a written yearly financial report to the general Association.
  - A. The treasurer's books are to be audited yearly at the General Association by the Auditing Committee.
  - B. The treasurer shall be bonded and said bond shall be paid for as general operating expenses.
- 3. Separate accounts and records shall be kept for home and foreign missions funds.
  - A. All undesignated funds received by the treasurer shall be subject to the discretion of the mission board, for either home or foreign mission purposes.
  - B. All funds received designated for a particular purpose shall be used entirely for such designated purpose. If such funds cannot be used for its designated purpose, they shall be returned to their donor and an explanation given as to why they could not be used.
  - C. A tax-exempt receipt shall be given upon request for all gifts and donations.
- 4. All general operating expenses of the board shall be paid for from the home mission fund.
- 5. The board shall have the authority to withdraw and use funds from their respective accounts for either home or foreign missionary projects.
  - A. Grants or loans cannot be made to any individual for personal use.
  - B. Grants or loans may be made for worthwhile purposes to District associations or churches which may request such aid.
  - C.\* Grant amounts given to any one church will be determined by the board. \*October 9, 1999, was changed at General Association from \$500/yr to any one church within an associational year
  - D.\* Loans may not exceed in the amount of one thousand (\$1,000) dollars and are to be repaid within a period designated at the time of said loan, but not to exceed five years. No interest shall be charged for money loaned. \*October 8, 1988, was changed at General Association to \$2,000.
  - E. A minimum of \$5,000.00 emergency fund will be maintained in the Foreign Mission Treasury.

- 6. All property purchased through the mission board for the establishment of a Separate Baptist Church shall be deeded to the trustees and their successors of the District association in which the church is established. (In event that the District association does not have trustees to which the property may be deeded, it shall remain deeded to Separate Baptist Missions, Incorporated)
- 7. All property purchased on the foreign field in behalf of Separate Baptist Missions, Inc. shall remain, where possible, the property of Separate Baptist Missions, Incorporated.

# Section Three Missionary Personnel

- 1. All missionaries serving under this board shall preach and teach according to the doctrinal statement of the General Association of Separate Baptist Churches.
- 2. All missionary candidates shall be examined by the board in regards to doctrinal, spiritual and mental requirements and shall furnish a doctor's statement on their physical condition.
- 3. All missionary candidates must do their deputation work with the mission board only assisting.
- 4. All missionaries shall serve pre-designated terms on the mission field and must spend a proportionate amount of time while on furlough in the states reporting to the churches which contributed to their support.
- 5. All missionaries must send regular monthly reports to the board concerning their work and progress while on the field.

# CONSTITUTION

**ARTICLE 1**. This body shall be called "The General Association of Separate Baptists in Christ" and shall be composed of ministers, deacons and delegates of the various District Associations and their several churches.

**ARTICLE 2.** Officers of this body shall be: Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, who shall be elected by this body and shall hold office one year or until their successors are elected, and shall serve free, except the Clerk, who shall be paid \$200.00 for his services by the Association.

**ARTICLE 3.** Duty of the moderator shall be: Preside at all meetings, appoint all committees and cast the deciding vote in the case of a tie. Duties of the Assistant Moderator shall be the same as the Moderator in case of his absence. The Clerk shall make complete Minutes of the proceedings of the Association, inserting in the Minutes the name and addresses of the ministers and church Clerks. The Clerk shall make completed minute books available to the churches no later than March 1 of each associational year if at all possible. The Assistant Clerk shall do the duties of the Clerk in his absence and assist the Clerk at any time he may need him. The Treasurer shall receive and pay out money and make a report at each meeting. No person shall hold more than one elected office in this organization. It shall be the duty of each District Association to contribute \$25.00 or more to the support of this body.

**ARTICLE 4.** The object of this body shall be to bring about a closer union and give united effort in putting forth the Word of Life.

**ARTICLE 5.** This Association thus formed shall be a council of advice and shall not exercise any undue authority over God's heritage. Each Association composing this body shall be entitled to three delegates from each church.

**ARTICLE 6.** This Association shall be governed by parliamentary rules.

**ARTICLE 7.** Any person wishing to address the body shall rise and address the Moderator.

**ARTICLE 8.** This body shall have a Mission Board which shall be authorized to oversee the Home and Foreign Mission aspects of our General Association. The said Mission Board shall be governed by the Rules and Regulations set forth by the General Association. Such Rules

and Regulations shall become a part of our General Association Constitution.

**ARTICLE 9.** Any Association belonging to this Association failing to report at each annual meeting, the Moderator shall appoint a committee to investigate why they did not report.

**ARTICLE 10.** Any Association applying for membership in this body shall be required to give evidence of its orthodoxy and shall agree to comply with the rules before being received into this body.

**ARTICLE 11.** This Constitution, By-Laws or Articles of Doctrine, may be changed or amended by a two-thirds vote\* of the body at any regular session, after having been tabled for a period of one associational year. Any changes that are to be made in the Constitution will be presented to the Constitution Committee prior to its submission to this body. The Constitution Committee shall consist of one member from each district association. The Moderator shall appoint a member to the Constitution Committee from each district association. Should the committee be required to convene to act upon any proposal and the appointed member be absent, the General Association's Moderator shall name a replacement.

• Pursuant to action taken at the 1991 General Association "twothirds vote" was defined as: "two-thirds of those who vote on that particular motion.

**ARTICLE 12.** The Pledges to American and Christian Flags and the Bible to be conducted by the Moderator at each morning session, prior to invocation and/or devotion.

# **BY-LAWS**

1. The Association or Church entertaining the General Association shall be given the privilege of setting the beginning time of each session to be held in that Association or Church and the entertaining Association or Church shall advise the Program Committee for the session about the starting time before the Program Committee reports to the body.

2. There shall not be anyone placed on a program or a committee that is not present at that session of the General Association.

3. Each District Association shall be responsible to list the names of all delegates and alternates from each church appointed to represent them at the General Association in or with their respective letter to the General Association. The delegates and alternates listed on or with the letter for the District Associations will be the only recognized appointed delegates to the General Association.

# **ARTICLES OF DOCTRINE**

**ARTICLE 1.** We believe that the Scriptures of the Old and New Testament are the infallible Word of God, and the only safe rule of faith and practice, using the King James version of the Holy Bible for Englishspeaking people (\*see below). Romans 15:4, 1 Corinthians 10:11, 2 Timothy 3:16-17, Genesis 1:1 through Revelation 22:21.

**ARTICLE 2.** We believe that there is in the God Head three Divine Personages: The Father, The Son and The Holy Spirit. Matthew 28:19, 1 Corinthians 12:3, 1 Timothy 2:5, Hebrews 1, 1 John 5:7.

**ARTICLE 3.** We believe that man is in a fallen state before God and is unable to liberate himself by any ability he may possess by nature. Isaiah 63:1-5, John 6:44, 14:6, Romans 8:1-20, 1 Corinthians 15:22.

**ARTICLE 4.** We believe that salvation, regeneration, sanctification, justification and redemption are through faith in the life, death and resurrection, ascension and intercession of our Lord and Saviour Jesus Christ. John 17:13-17, Hebrews 4:1-3, Ephesians 4:1-8, Titus 3:3-7, Revelation 1:18.

**ARTICLE 5.** We believe that he who endures to the end, the same shall be saved. Matthew 10:22, 24:13, Hebrews 3:12, 10:38-39, Revelation 2:10.

**ARTICLE 6.** We believe in the resurrection of the body, the just and the unjust, but every man in his own order, those who have done good, to eternal life, those who have done evil, to eternal damnation and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. Daniel 12:2, Matthew 25:46, Romans 5:21.

**ARTICLE 7.** We believe that the joys of the righteous and the punishment of the wicked are eternal. Daniel 12:2, Matthew 25:46, Romans 5:21.

**ARTICLE 8.** We believe that Baptism, the Lord's Supper and feet washing are ordained of Christ appointed in the Church and none but true believers are proper subjects, and that immersion is the Gospel mode of baptism. Matthew 28:19-20, Luke 22:17-20, John 13:14, Acts 2:41, Romans 6:4, Colossians 2:12.

**ARTICLE 9.** We believe in the sanctity of the first day of the week, or Lord's Day, and it should be spent in public or private worship, and we abstain from worldly concerns, except in case of necessity or mercy. Luke 23:56, John 20:26, Acts 20:7, 1 Corinthians 16:2, Revelation 1:10.

**ARTICLE 10.** We believe it is our duty to be tender, affectionate to one another, in honor preferring one another, to study the happiness of God's people in general and do all we can to support, promote and spread the Gospel. Isaiah 53:1-10, Romans 12:10, Galatians 6:1-2, 10, 2 Corinthians 9:14.

**ARTICLE 11.** We believe that Jesus Christ, by the Grace of God tasted death for everyman, that none can partake of His Holy Divine benefits except by repentance toward God and Faith in the Lord Jesus Christ; Infants and the innocent, due to lack of mental ability excepted, they being included in the covenant of God's Grace. Matthew 9:13, Luke 18:15-18, John 3:15-17, Acts 4:12, Romans 5:15, 1 Timothy 2:5-6.

**ARTICLE 12.** We believe that, at Christ's coming in the clouds of Heaven, all Christians will be gathered with Him in the clouds and that time shall be no more, thus leaving no time for a literal one thousand year reign. Matthew 24:29-31. Revelation 10:6, 1 Thessalonians 4:15-18,

2 Peter 3:10.

\*We believe that non-English speaking people should use a Bible comparable to the King James Version of the Holy Bible.
