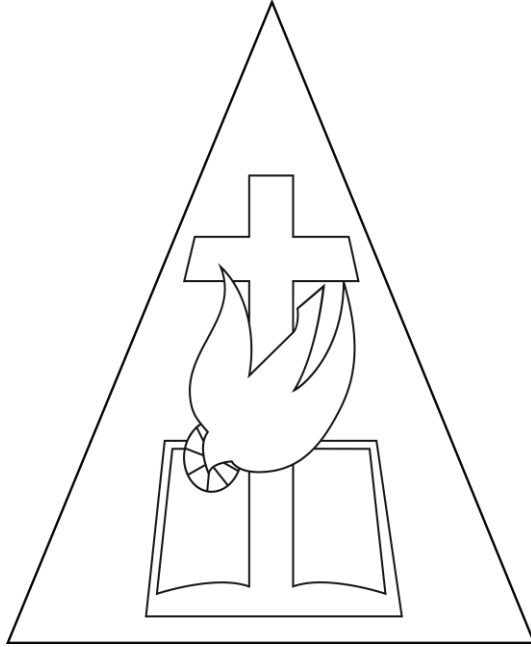

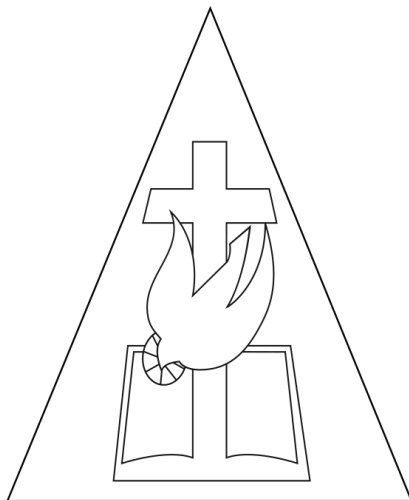

1. **Triangle**.....Trinity (Father, Son and Holy Spirit) as one.
2. **Cross**..... Salvation comes through Christ's sacrificial death on the cross into the church (crucified savior).
3. **Descending Dove**... Expresses innocence and humility and purity. It signifies the Holy Spirit and the presence of God and Jesus at his Baptism.
4. **Circle**.....Eternal, because it is without beginning and without end, everlasting life.
5. **Open Bible**.....Symbolizes the word of God, eternal truth, the great plan of life.

SUMMARY OF SYMBOL

That whosoever will believe in God, Son and Holy Spirit, and that Christ was crucified and He is our salvation and being Baptized with the Holy Spirit, believing in the word the eternal truth can be saved, we will have everlasting life.

The 102nd annual session of the General Association of Separate Baptists in Christ convened with the Nolynn Association at the Nolynn Campground in Magnolia, KY. The session was opened with Moderator Rev. Jimmy Polston asking Rev. Jim Goff of the Nolynn Association to come forward with the invocation. He read II Thess. 2:1-3. Prayer requests followed with Rev. Danny Bailey of South Kentucky leading us in prayer.

Rev. Polston had Rev. Johnny Perkins of Central Indiana pray the blessing over this setting of the association.

The Clerk read the letter from the **CENTRAL INDIANA Association**.

A motion to accept the letter, seat the delegates that are present and those that may come in later, and print the letter from Central Indiana Association was made and passed.

The letters from the following district associations were read with motions made and passed to receive the letters, seat the delegates that are present and those that may come in later, and print the letters in the minutes: **CHRISTIAN UNITY, MT. OLIVE, NOLYNN, SOUTH KENTUCKY, and WEST VIRGINIA.**

Unanimous consent was given by the Body to appoint Rev. Danny Bailey, Parliamentarian for the setting of this association.

Unanimous consent was given by the Body to appoint Bro. David Barr of Christian Unity to serve as the Assistant Moderator until Rev. Eudell Stilts arrives later today.

Bro. Rick Goff came forward and read the letters of correspondence from the Bethlehem Association of United Baptist Churches of Jesus Christ and Ancient Christian Association of United Baptist Churches. Motion was made and passed to accept the letters, print them in the minutes, and seat the delegates present and any that may come in later.

A call for new association(s) was made. None responded.

The Moderator had the visitors to stand to be recognized.

Rev. Neal Price of Nolynn asked the blessing on the congregational offering for Association expenses. Bro. Rick Goff of Nolynn led the congregation in singing “Victory in Jesus” as an offering totaling \$479 was received. Bro. Randy Polston of Central Indiana played the piano and Rev. Donnie Wiggington of Central Indiana played bass.

Assistant Moderator, Bro. David Barr of Christian Unity, introduced Rev. Jimmy Polston of Central Indiana as the minister to deliver the Introductory Sermon. Rev. Jimmy read from II Cor. 3 and II Cor. 4:1. A minister is to give aid and to serve. Rev. Jimmy pointed out that others than ministers have duties to “minister”. We all have

responsibilities to make a sacrifice unto the Lord. We need to have the “want to” in order to do the Lord’s work. A disciple is one that denies himself and daily takes up his cross to follow the Lord Jesus Christ. The power is in the Word, and the gospel must be preached in order for people to be saved. This is left up to the ministry. Rev. Jimmy referred to verse Acts 6:4, “But we will give ourselves continually to prayer, and to the ministry of the word.” The words that we share and do not share impact people’s lives. We need to always be found sharing the truth with people as our ministry for the Lord. He read Acts 20:22-24. He asked, “Where are our ministers”? “Where are our deacons”? “Where are our delegates when it comes time to meet at the General Association”? He read II Cor. 5:14-19. The love of Christ should keep us performing our daily duties as Christians. We have to believe the existence of God and the Lord Jesus Christ. If we allow God to have His way, we will be rewarded.

The congregation sang, “I’ll Meet You in the Morning”, “I’d Rather Be An Old-Time Christian”, “Jesus, Hold My Hand”, and “I’ll Meet You By the River” as the Saints fellowshiped around the altar shaking hands. Several wonderful testimonies followed in honor of our Lord.

The General Association Treasurer's report was given by Bro. Charles Jordan, Association Treasurer. Bro. Allen Wiggington made a motion to accept the report, refer it to the audit committee, print it in the minutes, and give a standing thanks to the Treasurer. Motion carried.

The Separate Baptist Missions, Inc. Treasurer's Report for Home & Foreign missions was given by Bro. Jimmie McGaha, SBMI Treasurer. Bro. Rick Goff made a motion to accept the reports, refer them to the audit committee, and print them in the minutes. Motion carried.

THE IMPORTANCE OF PREACHING THE GOSPEL:

Bro. Rick Goff of the Nolynn Association came forward to share his thoughts on this year's topic. He read Amos 8:11-12. There are bad things out in the world, but we are above it. Our nation as a whole does not appear to be above it. Bro. Rick read II Tim 4:3-4 and

Romans 10:13-15. We need our preachers, and we need to continue praying for them so that our religion does not fall by the wayside.

Bro. John Hall of Christian Unity came forward and read a quote from Abraham Lincoln. Bro. Hall continued to state that the real motivational speakers are those that preach the gospel while in the Holy Spirit. We need to get on fire for God. Love binds us together. There is hope in the Bible. When the Bible is preached, the Word becomes alive. We need to get right with God. Don't be discouraged when you face hard trials in your life. Victory is ours if we hold on to the truth. Repentance is not just for the world, but it is for the church as well.

Bro. Trent Whaley from Central Indiana came forward and spoke about how Jesus is the message. He shared what his pastor shared with him that if people cannot see Jesus in your life then something is wrong. He stated that people make it too hard, but it is simple: repent and find Jesus. Bro. Trent read Acts 3:17. We should point people to Jesus every day. We need to be like Jesus by teaching, preaching, and leading by example. We should be a disciple (follower) and an apostle as going forth to share Jesus. He referenced Luke 7:48 to show how Jesus did things to not satisfy the Pharisees, but instead, do things that were right. We can all be preachers by showing people Jesus.

Bro. Charles Jordan of the Nolynn Association brought the evening devotional by reading Article 10 of our Articles of Doctrine, Ecc 3:1, Eph 4:1-13, and II Cor. 6:17-18. We had prayer after hearing several prayer requests.

We next recognized visitors to the Association.

Rev. Matt Satter of Central Indiana came to deliver the morning devotional. He read II Timothy 2:1-7. After prayer requests, the saints prayed together led by Rev. Mike Wilson of Central Indiana.

The minutes of the Friday evening session were read and accepted with any necessary corrections or additions.

UNFINISHED BUSINESS:

We do NOT recommend any changes in our Articles of Doctrine themselves.

Motion was made and properly supported to accept the recommendation. Motion carried.

NEW BUSINESS:

There was no new business.

The **RESOLUTIONS** working committee report was read and accepted.

The following working committee reports were read and accepted: **ARRANGEMENTS, PROGRAM.**

The Moderator requested the body to graciously stand and give the Nolynn Association a standing vote of thanks for their outstanding work preparing for this year's associational meeting.

The Clerk continued with the following working committee reports, which were read and accepted: **WAYS AND MEANS, TEMPERANCE, AUDITING, OUTREACH.**

Rev. Gerald Gardner of the Nollynn Association led the congregation in the memorial prayer.

Rev. Danny Bailey, SBMI Chairman, updated us on the activities at home and in the Ivory Coast. He mentioned that we still have much work to do. SBMI is in dire need of a new truck for the Ivory Coast missions. Rev. Danny encouraged to never stop giving toward a vehicle for the Ivory Coast because the trucks and motorcycles have to be replaced so often due to the bad road conditions. He encouraged the delegation to donate to new Ivory Coast churches for our overseas brethren and sisters to worship in. Rev. Danny mentioned the threat of the Ebola virus knocking on the doors of the Ivory Coast. He also expressed great gratitude to Rev. Lonnie Palmer for his lifetime work in the Ivory Coast that laid the foundation for our current mission work. Please go back to your church and figure out ways to donate to this great work in the Ivory Coast (e.g. penny marches, offering percentage, specific offering of each month).

Rev. Danny stated that we currently have very little for home missions. He mentioned that the SBMI Board never has policed loans. The money has been loaned on the honor system. If there is a church that still owes money to SBMI due to a previous loan, please pay it back so that other churches that are in need can be granted the same financial benefit of having money loaned for their emergency needs.

Rev. Bailey introduced the Mission Board's choice to deliver the Mission sermon, Rev. Eddie Freeman of the Central Indiana Association. Rev. Eddie shared his experience in the Ivory Coast this past year which was his first time over there. He thanked everyone for their financial and spiritual support to make the mission trip happen. He read Acts 11:19-23 and II Cor. 9:7-8 before having prayer over the sermon. Rev. Eddie expressed his appreciation for the United States after performing mission work in the Ivory Coast. The living conditions are much rougher than what they are here.

Rev. Eddie talked about how hard it was to get from one village to the next in order to have church service. The journey was hard. He also discussed how great the financial expense was in the Ivory Coast.

He expressed his appreciation for Rev. Jerry in how he navigated around the country and recognizing the relationships that he has over there. He also expressed his appreciation for Rev. Lonnie Palmer in the work that he had done in the Ivory Coast. Rev. Eddie said that it was a shock to recognize the living conditions and to see the hopelessness in some of the children's eyes; however, the hope that they do have is in God and in the ministry that is happening. He stated that it was a strange feeling to be that far away from home. He also said that we should be farther along with this mission work than what we are today. It takes financial support and a desire from people to work in missions. Rev. Eddie expressed his strong dependence on God while he was over there. He shared stories of Rev. Jerry's and Rev. Josh's sickness and expressed how much he appreciated both of them especially Rev. Josh's positive attitude. We need more young people in the mission work. In closing, Rev. Eddie said that we needed more work in our home missions as well.

Rev. David Irwin of South KY asked the blessing on the SBMI offering. Bro. Stacy Wiggington of Central Indiana led the congregation in singing "Send the Light", "Bring Them In", "Love Lifted Me", "Showers of Blessing", "'Tis So Sweet To Trust In Jesus", and "Where the Soul Never Dies" with Bro. Keith Brown of Nolynn playing the piano, Rev. Donnie Wiggington of Central Indiana on bass, and Sis. Kelly Craven of Central Indiana played flute. The Mission offering was collected for a total of \$3000 during a Christian handshake.

Rev. James Hale of Nolynn prayed the dismissal and prayed the blessing on the noon meal. The house band entertained the congregation while going through the lunch line.

SATURDAY AFTERNOON 1:30 P.M.

The Saturday afternoon session was opened with Rev. Mike Wilson of Central Indiana leading the congregation in singing "Oh Say, But I'm Glad." Sis. Rebecca Smith of South KY played the piano and Sis. Kelly Craven of Central Indiana played flute.

Rev. Ed Tharpe of the Central Indiana Association came forward for the devotional. He read part of I Timothy 6:12 and Hebrews 11:32-40. Rev. James Hale of Nolynn led us in prayer after people gathered together sharing their prayer requests at the altar.

Rev. Neal Price of Nolynn asked the blessing on the offering for congregational expenses totaling \$219. Rev. Mike Wilson led the congregation in singing "Joy Unspeakable." Sis. Rebecca Smith played the piano along with Rev. Donnie Wiggington on bass and Sis. Kelly Craven on flute.

The minutes from the Saturday morning session were read and accepted with necessary additions or corrections.

UNFINISHED BUSINESS:

Bro. Allen Wiggington read the Outreach Committee appointments: Bro. Michael Jordan (Chairman), Rev. Danny Bailey, and Rev. Terry Thrasher.

Rev. David Irwin made a motion for people to go to the Clerk's desk to sign up as delegates for the Bethlehem, Centerpoint, Wills Creek, and Ancient Christian Associations. Motion carried.

If we trust in God, there's nothing to worry about. God will take care of everything if we serve God and live right. He preached that we don't need to be discouraged if we don't see the fruits of our labor the next day when doing God's work. Things will happen on God's time, and we need to trust that happening by continuing to be faithful. He preached that we have to put God before our family. There are times that we will have to rise up for the Lord. There are times that come in our lives that make us weep and make us laugh. There is a time for all things. God is a great God. 2014 Ministers and Deacons Conference Report

On Saturday, April 12th, seventy-five (75) ministers, deacons and their wives met at the Nolynn Campground for the 2014 Ministers and Deacons Conference. The theme for this year’s conference was, “The Mission of the Church.” The morning session was devoted to the Preacher/Pastor’s Perspective and the afternoon to the Deacon’s Perspective.

After congregational singing, Bro. Josh Carey of the South Kentucky Association led the morning devotional and called the congregation to the altar for prayer. Bro. Ray Unger of the Central Indiana Association and one of our eldest ministers gave the Preacher/Pastor’s Perspective. He began by giving a historical summary of early views of the church’s purpose and mission. He stated that in the early years of the church there was much persecution and yet the church flourished and grew. Constantine the Great (the first Roman emperor to

profess Christianity) thought that because of this growth and expansion the church's purpose was to rule the world. Later it was thought that the church's purpose was to make the world a better place to live. While this is not the main focus of the church it does achieve this purpose through the salvation of souls. Bro. Ray stated that the chief purpose of the church is the salvation of souls. He read several passages of scripture that illustrate this point.

Mark 16: 15 "And he said unto them, Go ye into all the world, and preach the gospel to every creature."

Matthew 28:18-20 "And Jesus came and spake unto them, saying, All power is given unto me in heaven and in earth. Go ye therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost: Teaching them to observe all things whatsoever I have commanded you: and, lo, I am with you alway, *even* unto the end of the world. Amen.

Bro. Ray said that he remembered Bro. Wavery Rosenbaum of the Mt. Olive Tennessee Association saying the church's purpose is to "Reach the lost with the gospel and then teach them what is right and wrong." He advanced that one of the great hindrances to the growth of the Separate Baptist church is the "doctrine" of "birthright Separate Baptist." This is an unbiblical idea. There are no grandparents in Christianity. God is our Father and the Church is our mother.

The biblical mandate to the church is to "Preach the word" 2 Tim. 4:2. Paul wrote this to Timothy yet he had no bible to read, he had only heard Paul and others preach.

He encouraged the preachers to "be instant", i.e. be ready at all times to represent the gospel and the church. "Newspapers like to publish 'preacher arrested' more than anything else." We must always be ready to carry the gospel to whomever the Lord sends us. It is easier to preach to 100 than to 10, but the Holy Spirit sent Philip to preach to one lost man, the Ethiopian eunuch.

If we aren't careful we confuse what God's purpose for us really is. Bro Ray stated, "Some people sing and then get happy. I get happy and then I sing, 'I'll be what you want me to be.' My prayer has always been and continues to be, 'Lord help me fulfill the work you've given me to do.'"

We then dismissed the morning session and shared a great meal together.

The congregation reconvened after lunch for the afternoon program. Bro. Johnny Davis of the South Kentucky Association gave the devotional. After prayer Bro. Wendell Benningfield began the Deacon's Perspective on the Mission of the Church. He read Acts 6:1-7 and stated that deacons are to care for the business and affairs of the church so the preachers can attend to preaching and the ministry of the word.

Bro. David Barr of the Christian Unity Association stated that the mission of the church is to: 1) Preach the Gospel; 2) Work to see people born again; 3) Teach the believers to observe the commands of the Lord. This is a noble yet simple task. The church has in many quarters lost focus and gotten discouraged from this great work. "We need to start a fire burning within us."

Bro. Jimmie McGaha of the Central Indiana Association stated that a mission is an assigned task. The assigned task of the church needs to be articulated so that the people in the church know what they should do. He read 1 Thessalonians 1:1 "Paul, and Silvanus, and Timotheus, unto the church of the

Thessalonians *which is* in God the Father and *in* the Lord Jesus Christ: Grace *be* unto you, and peace, from God our Father, and the Lord Jesus Christ.” The Edinburgh Separate Baptist Church has a mission statement to help guide the congregation in what it is to do. He stated several of these points. The purpose of the church is to “see people saved from eternal destruction and receive a home in heaven.” “We strive as a church to minister to our flock and to equip them to venture out into God’s service and to make disciples of others. We intend for our church to be a beacon.”

This was a wonderful conference and helped each in attendance to refocus on what the true mission of our church is.

BY-LAWS OF SEPARATE BAPTIST MISSIONS, INC.
UNDER
THE GENERAL ASSOCIATION OF SEPARATE BAPTISTS

Separate Baptist Missions, Inc.

Separate Baptist Missions, Incorporated shall be a religious non-profit incorporation for the establishment, furtherance and overseeing of Separate Baptist home and foreign missionary enterprises. The Incorporation shall be established in accordance with the laws of the state of Kentucky and shall be registered to conduct its lawful affairs and privileges in each state, either represented by an established Separate Baptist Church or represented for the establishment of a new Separate Baptist Church in fellowship with the General Association of Separate Baptists in Christ (hereafter referred to as the General Association).

Separate Baptist Missions, Incorporated shall consist of a board of three members who are elected for three-year terms by the General Association and of associational directors who will be elected or appointed to yearly terms by the District Associations. It shall be the duty of this board, in-as-much as possible, to carry out the desires of the General Association in all mission matters.

Separate Baptist Missions, Incorporated shall be governed with the by-laws established and approved by the General Association. The by-laws may be altered or amended at any General Association by a two-thirds majority vote of the voting delegates. No by-law, established or amended, shall knowingly violate the law(s) of the states under which this incorporation is registered.

Should this incorporation ever be dissolved, all records, monies and properties held by the incorporation at the time of dissolution shall be turned over to the General Association for disbursement as the General Association may deem necessary and proper.

**BY-LAWS
OF
SEPARATE BAPTIST MISSIONS INCORPORATED**
Section One
The Board

1. Separate Baptist Missions, Inc. shall have a board consisting of a chairman, a secretary, a treasurer, and associational directors. Each board member shall assume his responsibilities upon his election or appointment to office and shall serve in said office until his successor is elected or appointed. The board members shall obtain office and serve terms of duration as follows.

- A. The chairman of this board shall be elected by the General Association for a term of three years duration.
 - B. The treasurer of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the chairman's term.
 - C. The secretary of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the treasurer's term.
 - D. The associational directors of this board shall be elected by the District associations for a term of one year duration. They shall be elected yearly. There shall be one
Associational director elected from each District association.
2. All members of the board and personnel serving under the board must be Separate Baptist personnel.
3. A board member may be re-elected or re-appointed to successive terms.
4. The board of Separate Baptist Missions, Inc. shall meet at least once during every associational year other than at the General Association. They may also meet on assent of the board members when and as necessary. Written notices stating the time, date, location and purpose of each special board meeting shall be sent in advance to each board member.
5. A Quorum of five board members shall be required to transact official board business.
6. All board members shall serve without pay or reimbursement from mission funds *

(With the exception of the treasurer and the secretary who may be reimbursed from the Home Missions fund as deemed proper by the board).

* Changed October 12, 1991 at the General Association.

**Section Two
Funds and Property**

- 1. All funds are to be received on a voluntary manner and no church or District association shall ever be assessed for mission funds.
- 2. The treasurer of the board shall keep a permanent record of all receipts and expenditures and shall present a written yearly financial report to the general Association.

- A. The treasurer's books are to be audited yearly at the General Association by the Auditing Committee.
- B. The treasurer shall be bonded and said bond shall be paid for as general operating expenses.
- 3. Separate accounts and records shall be kept for home and foreign missions funds.
 - A. All undesignated funds received by the treasurer shall be subject to the discretion of the mission board, for either home or foreign mission purposes.
 - B. All funds received designated for a particular purpose shall be used entirely for such designated purpose. If such funds cannot be used for its designated purpose, they shall be returned to their donor and an explanation given as to why they could not be used.
 - C. A tax-exempt receipt shall be given upon request for all gifts and donations.
- 4. All general operating expenses of the board shall be paid for from the home mission fund.
- 5. The board shall have the authority to withdraw and use funds from their respective accounts for either home or foreign missionary projects.
 - A. Grants or loans cannot be made to any individual for personal use.
 - B. Grants or loans may be made for worthwhile purposes to District associations or churches which may request such aid.
 - C.* Grant amounts shall not exceed five thousand \$5,000.00 given to any one church within one associational year.
 - D.* Loans may not exceed in the amount of ten thousand (\$10,000) dollars and are to be repaid within a period designated at the time of said loan. No interest shall be charged for money loaned.
 - E. A minimum of \$5,000.00 emergency fund will be maintained in the Foreign Mission Treasury.
- 6. All property purchased through the mission board for the establishment of a Separate Baptist Church shall be deeded to the trustees and their successors of the District association in which the church is established. (In event that the District association does not have trustees to which the property may be deeded, it shall remain deeded to Separate Baptist Missions, Incorporated)
- 7. All property purchased on the foreign field in behalf of Separate Baptist Missions, Inc. shall remain, where possible, the property of Separate Baptist Missions, Incorporated. * Changed October 12, 2012 at the General Association.

Section Three

Missionary Personnel

- 1. All missionaries serving under this board shall preach and teach according to the doctrinal statement of the General Association of Separate Baptist Churches.
- 2. All missionary candidates shall be examined by the board in regards to doctrinal, spiritual and mental requirements and shall furnish a doctor's statement on their physical condition.
- 3. All missionary candidates must do their deputation work with the mission board only assisting.

4. All missionaries shall serve pre-designated terms on the mission field and must spend a proportionate amount of time while on furlough in the states reporting to the churches which contributed to their support.
5. All missionaries must send regular monthly reports to the board concerning their work and progress while on the field.

CONSTITUTION

ARTICLE 1: This body shall be called “The General Association of Separate Baptists in Christ” and shall be composed of ministers, deacons and delegates of the various District Associations and their several churches.

ARTICLE 2: Officers of this body shall be: Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer and Corresponding Secretary who shall be elected by this body and shall hold office one year or until their successors are elected, and shall serve free, except the Clerk, who shall be paid \$200.00 for his services by the Association.

ARTICLE 3: Duty of the moderator shall be: Preside at all meetings, appoint all committees and cast the deciding vote in the case of a tie. Duties of the Assistant Moderator shall be the same as the Moderator in case of his absence. The Clerk shall make complete Minutes of the proceedings of the Association, inserting in the Minutes the name and addresses of the ministers and church Clerks. The Clerk shall make completed minute books available to the churches no later than March 1 of each associational year if at all possible. The Assistant Clerk shall do the duties of the Clerk in his absence and assist the Clerk at any time he may need him. The Treasurer shall receive and pay out money and make a report at each meeting. The Corresponding Secretary shall correspond with other associations, groups or individuals as directed by this body. No person shall hold more than one elected office in this organization. It shall be the duty of each District Association to contribute \$25.00 or more to the support of this body.

ARTICLE 4: The object of this body shall be to bring about a closer union and give united effort in putting forth the Word of Life.

ARTICLE 5: This Association thus formed shall be a council of advice and shall not exercise any undue authority over God’s heritage. Each Association composing this body shall be entitled to three delegates from each church.

ARTICLE 6: This Association shall be governed by parliamentary rules.

ARTICLE 7: Any person wishing to address the body shall rise and address the Moderator.

ARTICLE 8: This body shall have a Mission Board which shall be authorized to oversee the Home and Foreign Mission aspects of our General Association. The said Mission Board shall be governed by the Rules and Regulations set forth

by the General Association. Such Rules and Regulations shall become a part of our General Association Constitution.

ARTICLE 9: Any Association belonging to this Association failing to report at each annual meeting, the Moderator shall appoint a committee to investigate why they did not report.

ARTICLE 10: Any Association applying for membership in this body shall be required to give evidence of its orthodoxy and shall agree to comply with the rules before being received into this body.

ARTICLE 11: This Constitution, By-Laws or Articles of Doctrine, may be changed or amended by a two-thirds vote* of the body at any regular session, after having been tabled for a period of one associational year. Any changes that are to be made in the Constitution will be presented to the Constitution Committee prior to its submission to this body. The Constitution Committee shall consist of one member from each district association. The Moderator shall appoint a member to the Constitution Committee from each district association. Should the committee be required to convene to act upon any proposal and the appointed member be absent, the General Association's Moderator shall name a replacement.

*Pursuant to action taken at the 1991 General Association "two-thirds vote" was defined as: "two-thirds of those who vote on that particular motion."

ARTICLE 12: The Pledges to American and Christian Flags and the Bible to be conducted by the Moderator at each morning session, prior to invocation and/or devotion.

BY-LAWS

1. The Association or Church entertaining the General Association shall be given the privilege of setting the beginning time of each session to be held in that Association or Church and the entertaining Association or Church shall advise the Program Committee for the session about the starting time before the Program Committee reports to the body.

2. There shall not be anyone placed on a program or a committee that is not present at that session of the General Association.

3. Each District Association shall be responsible to list the names of all delegates and alternates from each church appointed to represent them at the General Association in or with their respective letter to the General Association. The delegates and alternates listed on or with the letter for the District Associations will be the only recognized appointed delegates to the General Association.

ARTICLES OF DOCTRINE

ARTICLE 1: We believe that the Scriptures of the Old and New Testament are the infallible Word of God, and the only safe rule of faith and practice, using the King James version of the Holy Bible for English-speaking people (*see below). Romans 15:4, 1 Corinthians 10:11, 2 Timothy 3:16-17, Genesis 1:1 through Revelation 22:21.

ARTICLE 2: We believe that there is in the God Head three Divine Personages: The Father, The Son and The Holy Spirit. Matthew 28:19, 1 Corinthians 12:3, 1 Timothy 2:5, Hebrews 1, 1 John 5:7.

ARTICLE 3: We believe that man is in a fallen state before God and is unable to liberate himself by any ability he may possess by nature. Isaiah 63:1-5, John 6:44 & 14:6, Romans 8:1-20, 1 Corinthians 15:22.

ARTICLE 4: We believe that salvation, regeneration, sanctification, justification and redemption are through faith in the life, death and resurrection, ascension and intercession of our Lord and Saviour Jesus Christ. John 17:13-17, Hebrews 4:1-3, Ephesians 4:1-8, Titus 3:3-7, Revelation 1:8.

ARTICLE 5: We believe that he who endures to the end, the same shall be saved. Matthew 10:22, 24:13, Hebrews 3:12, 10:38-39, Revelation 2:10.

ARTICLE 6: We believe in the resurrection of the body, the just and the unjust, but every man in his own order, those who have done good, to eternal life, those who have done evil, to eternal damnation and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. Daniel 12:2, Matthew 25:46, Romans 5:21.

ARTICLE 7: We believe that the joys of the righteous and the punishment of the wicked are eternal. Daniel 12:2, Matthew 25:46, Romans 5:21.

ARTICLE 8: We believe that Baptism, the Lord's Supper and feet washing are ordained of Christ appointed in the Church and none but true believers are proper subjects, and that immersion is the Gospel mode of baptism. Matthew 28:19-20, Luke 22:17-20, John 13:14, Acts 2:41, Romans 6:4, Colossians 2:12.

ARTICLE 9: We believe in the sanctity of the first day of the week, or Lord's Day, and it should be spent in public or private worship, and we abstain from worldly concerns, except in case of necessity or mercy. Luke 23:56, John 20:26, Acts 20:7, 1 Corinthians 16:2, Revelation 1:10.

ARTICLE 10: We believe it is our duty to be tender, affectionate to one another, in honor preferring one another, to study the happiness of God's people in general and do all we can to support, promote and spread the Gospel. Isaiah 53:1-10, Romans 12:10, Galatians 6:1-2, 10, 2 Corinthians 9:14.

ARTICLE 11: We believe that Jesus Christ, by the Grace of God tasted death for everyman, that none can partake of His Holy Divine benefits except by repentance toward God and Faith in the Lord Jesus Christ; Infants and the innocent, due to lack of mental ability excepted, they being included in the covenant of God's Grace. Matthew 9:13, Luke 18:15-18, John 3:15-17, Acts 4:12, Romans 5:15, 1 Timothy 2:5-6.

ARTICLE 12: We believe that, at Christ's coming in the clouds of Heaven, all Christians will be gathered with Him in the clouds and that time shall be no more, thus leaving no time for a literal one thousand year reign. Matthew 24:29-31. Revelation 10:6, 1 Thessalonians 4:15-18, 2 Peter 3:10.

*We believe that non-English speaking people should use a Bible comparable to the King James Version of the Holy Bible.
