



Session Minutes

OCTOBER 9, 2015 FRIDAY MORNING 10:00 A.M.

The 103rd annual session of the General Association of Separate Baptists in Christ convened with the Central Indiana Association at the Midway Campground in Fruitdale, IN. The session was opened with Moderator Rev. Jimmy Polston asking Bro. Scott Polston of South KY to lead the congregation in singing "Living by Faith" as Bro. Rick Goff of Nolynn played the piano. Rev. Clifton Cowan of South KY came forward with the invocation reading. He read Genesis 21:33-34. Rev. Homer Whited of Central IN led us in prayer.

Bro. Scott Polston of the South KY Association led the congregation in singing, "Praise Him! Praise Him!" as Bro. Rick Goff of the Nolynn Association played the piano.

The Moderator, Rev. Jimmy Polston, called the body to order. Rev. Jimmy Polston led the congregation in pledges to the American Flag, Christian Flag, and Bible, respectively. We observed a moment of silence in prayer for our service personnel followed by a prayer led by Bro. Olyn Sprowles of the Nolynn Association.

Rev. Polston had Rev. Matt Satter of Central Indiana pray the blessing over this setting of the association.

The Clerk read the letter from the **CENTRAL INDIANA** Association.

A motion to accept the letter, seat the delegates that are present and those that may come in later, and print the letter from Central Indiana Association was made and passed.

The remaining letters were read from the following district associations with motions made and passed to receive the letters, seat the delegates that are present and those that may come in later, and print the letters in the minutes: CHRISTIAN UNITY, MT. OLIVE, NOLYNN, SOUTH KENTUCKY, and WEST VIRGINIA.

Unanimous consent was given by the Body to appoint Rev. Danny Bailey as the Parliamentarian for the setting of this association. Motion was made by Bro. Allen Wiggington to elect an Assistant Moderator for this session due to the absence of Rev. Eudell Stilts. Motion passed. Rev. Jerry Ridge of Central Indiana was elected to serve as the Assistant Moderator.

Bro. Rick Goff came forward and read the letter from the Bethlehem Association of United Baptist Churches of Jesus Christ. Motion was made and passed to accept the letter and print it in the minutes.

The Clerk then read the Articles of Doctrine.

A call for new association(s) was made. None responded. The Moderator had the visitors to stand to be recognized.

Rev. Ed Tharpe of Central Indiana asked the blessing on the congregational offering for Association expenses. Bro. Scott Polston of South KY led the congregation in singing "Mansion over the Hilltop", accompanied by Sis. Phyllis Wiggington of Central Indiana on piano, as an offering totaling \$429 was received.

Our Moderator introduced Rev. Rick Owensby of Central Indiana as the minister to deliver the Introductory Sermon. Rev. Rick read from Mathew 5:13-16. People today want to be on spiritual welfare. They want to be blessed, but not do what it takes to be blessed. We are the light of the world. Rev. Rick asked us, "If we are a city set on a hill, why aren't we being seen?" He read II Cor. 4:1-6. We need to be seen. We need to just tell the truth and not compromise our way of worship. He preached that we need to stand up for this ministry. One sacrifice, for sin, forever is the truth. So why aren't we being seen? He posed the questions, "Are there more goats than sheep in the flock? Is the sign better than what's being offered?" We spend too much time wasting God's time. Rev. Rick left us with to not be invisible and be what the sign says.

The congregation sang "More About Jesus", "When We All Get to Heaven", "I'll Fly Away", and "He Set Me Free" as the Saints fellowshipped around the altar shaking hands. Bro. Scott Polston of South KY led us in singing as Bro. Rick Goff of Nolynn played the piano, and Rev. Danny Bailey of South KY played guitar.

The partial report of the Divine Service Committee was read and accepted.

The Friday afternoon service was opened with Rev. Josh Polston of the South KY Association leading the congregation in singing, "Somebody Loves Me" as Bro. Jon Polston played the piano.

Rev. Josh Polston of the South KY Association had charge of the afternoon devotional service. He read I Cor. 2:1-5. After prayer requests were made, the saints joined in prayer with Bro. Benny Walden of Central Indiana leading.

The Assistant Clerk read the minutes of the morning session. A motion was made and properly supported to accept the minutes with any necessary corrections and additions and print them in book form. The motion carried.

UNFINISHED BUSINESS:

Motion was made and passed to accept the amendment of the Divine Committee's Saturday morning devotion appointee, Rev. Nathan Hunter.

The Constitution Committee Reports were read. The first report read as follows:

On References for Articles of Faith

During the Saturday morning session of the 2014 General Association, the Constitution Committee was asked by the Moderator to examine all references to our Articles of Doctrine.

A report on the references for Articles 6 and 7 will be found in a separate report.

We find that the references for Articles 1-5, and for Articles 8-12 all appear to support the Articles for which they are given, with the exception of the first reference given for Article 10.

Isaiah 53:1-10 does not appear to refer to any part of Article 10, but each of the other references given for that Article do.

We would recommend that Isaiah 53:1-10 be removed from the list of references for Article 10.

Respectfully submitted by the 2014-2015 Constitution Committee.

PS: We would recommend that the references for all of our Articles of Doctrine be reviewed by the Constitution Committee annually. (Bro. Charles E. Jordan, Sr., Chairman, Rev. Eddie Freeman, Bro. Albert Polston, Bro. John Hall)

The second report read as:

On Friday afternoon of the 2014 General Association meeting, Rev. Ed Tharpe asked if the references for Articles 6 and 7 in our Articles of Doctrine were accurate since they were identical references. The Moderator referred the issue to the Constitution Committee to investigate.

We were given the following statement to investigate: "Since 2003, Articles 6 & 7 of the Articles of Doctrine have had the same scriptural references."

Our investigation found the following:

Our research finds that, since at least 1974 through 1987, these Articles were listed in our Minute Books (sometimes by different Article numbers).

The present Article 6 was referenced by Daniel 12:2, Matthew 24:30, 25:31-46, I Thessalonians 4:16.

The present Article 7 was referenced by Daniel 12:2, Matthew 25:46, Romans 5:21.

In the 1988-1990 Minute Books, the present Article 6 was listed, referencing Daniel 12:2, Matthew 25:46, Romans 5:21.

There was no mention of the present Article 7 (the Minute Book listed Articles 1-6, 8-11. There was no Article number 7 listed for those years).

In the Minute Books for 1991 through 2014, both Articles 6 and 7 were listed, referencing Daniel 12:2, Matthew 25:46, and Romans 5:21 for both Articles.

These references do apply for both Articles 6 and 7. We would recommend that Matthew 25:31-46 be included for Article 6, as it was before 1988.

Respectfully submitted by the 2014-2015 Constitution Committee. (Bro. Charles E. Jordan, Sr., Chairman, Rev. Eddie Freeman, Bro. John Hall, Bro. Albert Polston) Both reports were tabled for next year.

Motion was made and properly supported to bring the 2014 tabled motion from the table: We propose that in the references for Article 6, Romans 5:21 be replaced by Acts 17:31. Motion carried. After little discussion, the body voted for the replacement.

The Clerk read the 2015 General Association Ministers' and Deacons' Conference Committee report. Motion was made to accept the report, print it in the minutes, and refer the financial portion to the Audit Committee. Motion passed.

The General Association Treasurer's report was given by Bro. Charles Jordan. Bro. Charles Jordan made a motion to accept the report, refer it to the Audit Committee, and print it in the minutes. Motion carried.

The Separate Baptist Missions, Inc. Treasurer's Report for Home & Foreign missions was given by Bro. Jimmie McGaha, SBMI Treasurer. Rev. Danny Bailey made a motion to accept the reports, refer them to the Audit Committee, and print them in the minutes. Motion carried.

HOW TO GROW THE CHURCH

Involving the Youth in Service:

Bro. Randy Kennedy of the Nolynn Association mentioned how Disney World is not a perfect place although it is a fun place. President Obama's creation of the Social and Behavioral Sciences Team is another way to legally promote propaganda which is essentially lying to the American public. We do not need to allow our government and media to teach our children the difference between right and wrong because they are not going to get it right much like the homosexuality topic of today. Whether we are talking about actual children or new converts into Christianity, we need to get them involved in our church services for them to have a sense of ownership, responsibility, and loyalty to the church. This can be done by involving them in taking part in singing, having a part in church plays, taking up offering, and getting them accustomed to communion and foot washing. We may have to step out of our comfort zones to be the teacher. Start today in order to develop a stronger church for the future.

Role of a Mentor:

Rev. Donnie Wiggington of Central Indiana read Proverbs 27:17, 22:6, and 27:23. We need mentors because we need someone to believe in us. He told us what his dad always told him, "One day you'll be accountable for what you said and everything that you didn't say." He talked about how Moses believed in Joshua. We need someone to provide the image of a role model. We need to surround ourselves with people who not only talk the talk, but walk the walk. The best role model that we can have as Christians is Christ. Our role models should encourage spiritual growth. Mentors provide accountability. The Holy Spirit keeps us accountable. A mentor should be an encourager. You may find yourself needing to serve as a mentor. Mentors need to be available during times of crisis. A mentor helps to establish and achieve goals. Provide trust in counsel. Mentoring provides benefits in our other

relationships. It also provides an opportunity to give back. It takes a church to raise a child.

Role of Leadership:

Rev. David Irwin of South KY came forward to discuss leaders that served an important role in his life. Rev. Jim Tharpe and Rev. Jerry Ridge were some of those Christian men that served that role in his life. Rev. David read the first part of Rev. 3:2. Rev. David shared his emotional testimony concerning his son getting saved while going through cancer. He said that is the purest form of leadership when someone recently saved wants to go tell everyone about being saved. Rev. David concluded that he doesn't feel like he knows how to lead, but he wants to follow the one that does, Jesus Christ.

Rev. Matt Satter of Central Indiana asked the blessing on the offering as the congregation sang "I'll Be a Friend to Jesus" as \$278.98 was collected. Rev. Josh Polston of South KY led the singing with Bro. Jon Polston of South KY accompanying him on piano.

Rev. Danny Bailey of South KY delivered the afternoon sermon, reading Ecc. 3:14. He preached that the method that Satan tempted Eve to come to him is still the same method that is used today. Satan creates doubt, and it is easier when we do not firmly know the difference between right and wrong. Rev. Danny preached that he did not grow up Separate Baptist and that his church talked about foot washing, but did not practice it. You only believe the part of the Bible that you do. You do not really believe it unless you do it. We are as guilty as anyone else about picking pieces out of the Bible on what we want to believe or practice. God demands our obedience; however, God does not make us do anything because we are free moral agents. Many people have tried to discredit the Bible, but they cannot since God is in it. People can distort it, and that is why there are so many various versions of the Bible. He recited Psalm 2:1. Rev. Danny touched on how the Supreme Court has tried to redefine marriage, but that does not redefine it from God's terms. He preached how God's plan was always for Jesus to come into the world to die for the world's sins. The Jews in Jesus' day was expecting a military leader and were surprised to see him when he appeared after the third day from being dead. The end of time is on our doorstep. It does not matter if people believe in God or not, he will bring this world to an end when it is time to fulfill His plan. Rev. Danny left us with, "What do you know today?"

Rev. David Irwin of the South KY Association led the congregation in the memorial prayer after mentioning Rev. Lonnie Palmer.

Rev. Danny Bailey, SBMI Chairman, came forward and continued talking about the significance of losing Rev. Lonnie Palmer. Rev. Danny also mentioned the important role that Rev. R. G. Flexon served in his life as well. Rev. Danny informed us that it was Rev. Lonnie Palmer that started the work in the Ivory Coast and handed that mission to the Separate Baptists.

Rev. Danny discussed Home Missions. We need to continue to pray for Pleasant Home Separate Baptist Church in the Mt. Olive Association. Pray for the Nolynn Association which currently has six churches without pastors. Home Missions helped Rev. Johnny Perkins purchase a new tent for his tent revivals.

Rev. Danny mentioned that Rev. Jerry Ridge and Rev. Rick Owensby went to the Ivory Coast this past year. They were able to purchase a new truck for the mission work. Mission board requested Rev. Jerry to start looking for new property in the Ivory Coast for a new missionary house. Rev. Jerry found a little over a third of an acre property in Bondoukou that provides running water and electricity. The Christians have already cleared the property and have started building blocks for the new house. Money has already been collected for a washer and dryer, but funds are still needed to provide other house furnishings. If your church is looking for a project to support, please help SBMI fund this new missionary house. Projected costs will be somewhere near \$40K. Rev. Danny recounted his first visit to the Ivory Coast. The Christians there are so appreciative of the support that comes from the Separate Baptists.

Rev. Danny mentioned that Rev. Jerry Ridge is heading back to the Ivory Coast in January and July. SBMI is requesting financial support to offset the traveling expenses involved for Rev. Jerry and others to travel to do God's work. Traveling costs are not cheap. Rev. Danny mentioned the work in Haiti that Rev. Randy Brown has been conducting. The latest work for sending eyeglasses has been successful. SBMI thanks everyone for their support. They had around 3,000 eyeglasses to hand out to those in need. SBMI is hoping to provide this support to Ivory Coast as well.

Rev. Randy Brown has been preaching and teaching seminars in Haiti upon the Haitians' request. He has been asked to bring a group of preachers in February 2016 and to start a Vacation Bible School in the summer of 2016. This is an extremely exciting time for us to see God's work being done.

Rev. Bailey introduced the Mission Board's choice to deliver the Mission sermon, Rev. Terry Thrasher of the South KY Association. Rev. Terry read Romans 10. Rev. Terry informed us that the word "mission" means "the act of sending". We live in a time when there are probably more informed people in the world than ever before, but it is also the time of more ignorance. The Word of God is not just for "them", it is for "us". Do we fear the Lord like we need to today? We also have a tendency to say that "someone needs to be doing this or that" instead of thinking that it may just be us that needs to be doing it. We need to be more like Isaiah when he exclaimed, "Here am I Lord! Send me!" Rev. Terry preached that we need to make sure that we are in the plan of God. We need to be ready and willing to perform God's work. There is a great work to be done, but it does not need to fall on the heads of two or three people. We all need to be involved. We are reaping the harvests of someone else's work, but it is ready to expand. The whole world is wide open to us to provide mission work. He preached that we need to listen to the Lord and follow his lead. The Gospel is the power of God. Rev. Terry preached that there is no room for prejudice in the church. We are all of one blood. The message today needs to be a message of repentance. The mission is to preach the Gospel to get people saved to avoid hell. We all have influence on someone. The question is, "How are we influencing them?" We need to strive to be part of the Lord's work.

Rev. Nathan Hunter of Central Indiana asked the blessing on the SBMI offering. Bro. Stacy Wiggington of Central Indiana led the congregation in singing several songs with Bro. Jon Polston of South KY playing the piano while the Mission offering was collected for a total of \$1,416 during a Christian handshake.

Rev. Matt Cowan of South KY prayed the blessing on the noon meal, and Rev. Clifton Cowan of South KY prayed the dismissal.

BY-LAWS OF SEPARATE BAPTIST MISSIONS, INC. UNDER THE GENERAL ASSOCIATION OF SEPARATE BAPTISTS

Separate Baptist Missions, Inc.

Separate Baptist Missions, Incorporated shall be a religious non-profit incorporation for the establishment, furtherance and overseeing of Separate Baptist home and foreign missionary enterprises. The Incorporation shall be established in accordance with the laws of the state of Kentucky and shall be registered to conduct its lawful affairs and privileges in each state, either represented by an established Separate Baptist Church or represented for the establishment of a new Separate Baptist Church in fellowship with the General Association of Separate Baptists in Christ (hereafter referred to as the General Association).

Separate Baptist Missions, Incorporated shall consist of a board of three members who are elected for three-year terms by the General Association and of associational directors who will be elected or appointed to yearly terms by the District Associations. It shall be the duty of this board, in-as-much as possible, to carry out the desires of the General Association in all mission matters.

Separate Baptist Missions, Incorporated shall be governed with the bylaws established and approved by the General Association. The by-laws may be altered or amended at any General Association by a two-thirds majority vote of the voting delegates. No by-law, established or amended, shall knowingly violate the law(s) of the states under which this incorporation is registered.

Should this incorporation ever be dissolved, all records, monies and properties held by the incorporation at the time of dissolvement shall be turned over to the General Association for disbursement as the General Association may deem necessary and proper.

BY-LAWS OF

SEPARATE BAPTIST MISSIONS INCORPORATED

Section One

The Board

- Separate Baptist Missions, Inc. shall have a board consisting of a chairman, a secretary, a treasurer, and associational directors. Each board member shall assume his responsibilities upon his election or appointment to office and shall serve in said office until his successor is elected or appointed. The board members shall obtain office and serve terms of duration as follows.
 - A. The chairman of this board shall be elected by the General Association for a term of three years duration.
 - B. The treasurer of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the chairman's term.
 - C. The secretary of this board shall be elected by the General Association for a term of three years duration with his term expiring the year prior to the expiration of the treasurer's term.
 - D. The associational directors of this board shall be elected by the District associations for a term of one year duration. They shall be elected yearly. There shall be one Associational director elected from each District association.
- All members of the board and personnel serving under the board must be Separate Baptist personnel.
- 3. A board member may be re-elected or re-appointed to successive terms.
- 4. The board of Separate Baptist Missions, Inc. shall meet at least once during every associational year other than at the General Association. They may also meet on assent of the board members when and as necessary. Written notices stating the time, date, location and purpose of each special board meeting shall be sent in advance to each board member.
- A Quorum of five board members shall be required to transact official board business
- 6. All board members shall serve without pay or reimbursement from mission funds *

(With the exception of the treasurer and the secretary who may be reimbursed from the Home Missions fund as deemed proper by the board).

* Changed October 12, 1991 at the General Association.

Section Two Funds and Property

- 1. All funds are to be received on a voluntary manner and no church or District association shall ever be assessed for mission funds.
- The treasurer of the board shall keep a permanent record of all receipts and expenditures and shall present a written yearly financial report to the general Association.

- A. The treasurer's books are to be audited yearly at the General Association by the Auditing Committee.
- B. The treasurer shall be bonded and said bond shall be paid for as general operating expenses.
- Separate accounts and records shall be kept for home and foreign missions funds.
 - A. All undesignated funds received by the treasurer shall be subject to the discretion of the mission board, for either home or foreign mission purposes.
 - B. All funds received designated for a particular purpose shall be used entirely for such designated purpose. If such funds cannot be used for its designated purpose, they shall be returned to their donor and an explanation given as to why they could not be used.
 - A tax-exempt receipt shall be given upon request for all gifts and donations.
- All general operating expenses of the board shall be paid for from the home mission fund.
- 5. The board shall have the authority to withdraw and use funds from their respective accounts for either home or foreign missionary projects.
 - A. Grants or loans cannot be made to any individual for personal use.
 - B. Grants or loans may be made for worthwhile purposes to District associations or churches which may request such aid.
 - C.* Grant amounts shall not exceed five thousand \$5,000.00 given to any one church within one associational year.
 - D.* Loans may not exceed in the amount of ten thousand (\$10,000) dollars and are to be repaid within a period designated at the time of said loan. No interest shall be charged for money loaned.
 - E. A minimum of \$5,000.00 emergency fund will be maintained in the Foreign Mission Treasury.
- 6. All property purchased through the mission board for the establishment of a Separate Baptist Church shall be deeded to the trustees and their successors of the District association in which the church is established. (In event that the District association does not have trustees to which the property may be deeded, it shall remain deeded to Separate Baptist Missions, Incorporated)
- All property purchased on the foreign field in behalf of Separate Baptist Missions, Inc. shall remain, where possible, the property of Separate Baptist Missions, Incorporated.
 - * Changed October 12, 2012 at the General Association.

Section Three Missionary Personnel

- All missionaries serving under this board shall preach and teach according to the doctrinal statement of the General Association of Separate Baptist Churches.
- All missionary candidates shall be examined by the board in regards to doctrinal, spiritual and mental requirements and shall furnish a doctor's statement on their physical condition.
- 3. All missionary candidates must do their deputation work with the mission board only assisting.

- 4. All missionaries shall serve pre-designated terms on the mission field and must spend a proportionate amount of time while on furlough in the states reporting to the churches which contributed to their support.
- All missionaries must send regular monthly reports to the board concerning their work and progress while on the field.

CONSTITUTION

ARTICLE 1: This body shall be called "The General Association of Separate Baptists in Christ" and shall be composed of ministers, deacons and delegates of the various District Associations and their several churches.

ARTICLE 2: Officers of this body shall be: Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer and Corresponding Secretary who shall be elected by this body and shall hold office one year or until their successors are elected, and shall serve free, except the Clerk, who shall be paid \$200.00 for his services by the Association.

ARTICLE 3: Duty of the moderator shall be: Preside at all meetings, appoint all committees and cast the deciding vote in the case of a tie. Duties of the Assistant Moderator shall be the same as the Moderator in case of his absence. The Clerk shall make complete Minutes of the proceedings of the Association, inserting in the Minutes the name and addresses of the ministers and church Clerks. The Clerk shall make completed minute books available to the churches no later than March 1 of each associational year if at all possible. The Assistant Clerk shall do the duties of the Clerk in his absence and assist the Clerk at any time he may need him. The Treasurer shall receive and pay out money and make a report at each meeting. The Corresponding Secretary shall correspond with other associations, groups or individuals as directed by this body. No person shall hold more than one elected office in this organization. It shall be the duty of each District Association to contribute \$25.00 or more to the support of this body.

ARTICLE 4: The object of this body shall be to bring about a closer union and give united effort in putting forth the Word of Life.

ARTICLE 5: This Association thus formed shall be a council of advice and shall not exercise any undue authority over God's heritage. Each Association composing this body shall be entitled to three delegates from each church.

ARTICLE 6: This Association shall be governed by parliamentary rules.

ARTICLE 7: Any person wishing to address the body shall rise and address the Moderator.

ARTICLE 8: This body shall have a Mission Board which shall be authorized to oversee the Home and Foreign Mission aspects of our General Association. The said Mission Board shall be governed by the Rules and Regulations set forth

by the General Association. Such Rules and Regulations shall become a part of our General Association Constitution.

ARTICLE 9: Any Association belonging to this Association failing to report at each annual meeting, the Moderator shall appoint a committee to investigate why they did not report.

ARTICLE 10: Any Association applying for membership in this body shall be required to give evidence of its orthodoxy and shall agree to comply with the rules before being received into this body.

ARTICLE 11: This Constitution, By-Laws or Articles of Doctrine, may be changed or amended by a two-thirds vote* of the body at any regular session, after having been tabled for a period of one associational year. Any changes that are to be made in the Constitution will be presented to the Constitution Committee prior to its submission to this body. The Constitution Committee shall consist of one member from each district association. The Moderator shall appoint a member to the Constitution Committee from each district association. Should the committee be required to convene to act upon any proposal and the appointed member be absent, the General Association's Moderator shall name a replacement.

*Pursuant to action taken at the 1991 General Association "two-thirds vote" was defined as: "two-thirds of those who vote on that particular motion.

ARTICLE 12: The Pledges to American and Christian Flags and the Bible to be conducted by the Moderator at each morning session, prior to invocation and/or devotion.

BY-LAWS

- 1. The Association or Church entertaining the General Association shall be given the privilege of setting the beginning time of each session to be held in that Association or Church and the entertaining Association or Church shall advise the Program Committee for the session about the starting time before the Program Committee reports to the body.
- 2. There shall not be anyone placed on a program or a committee that is not present at that session of the General Association.
- 3. Each District Association shall be responsible to list the names of all delegates and alternates from each church appointed to represent them at the General Association in or with their respective letter to the General Association. The delegates and alternates listed on or with the letter for the District Associations will be the only recognized appointed delegates to the General Association.

ARTICLES OF DOCTRINE

- **ARTICLE 1:** We believe that the Scriptures of the Old and New Testament are the infallible Word of God, and the only safe rule of faith and practice, using the King James version of the Holy Bible for English-speaking people (*see below). Romans 15:4, 1 Corinthians 10:11, 2 Timothy 3:16-17, Genesis 1:1 through Revelation 22:21.
- **ARTICLE 2:** We believe that there is in the God Head three Divine Personages: The Father, The Son and The Holy Spirit. Matthew 28:19, 1 Corinthians 12:3, 1 Timothy 2:5, Hebrews 1, 1 John 5:7.
- **ARTICLE 3:** We believe that man is in a fallen state before God and is unable to liberate himself by any ability he may possess by nature. Isaiah 63:1-5, John 6:44 & 14:6, Romans 8:1-20, 1 Corinthians 15:22.
- **ARTICLE 4:** We believe that salvation, regeneration, sanctification, justification and redemption are through faith in the life, death and resurrection, ascension and intercession of our Lord and Saviour Jesus Christ. John 17:13-17, Hebrews 4:1-3, Ephesians 4:1-8, Titus 3:3-7, Revelation 1:18.
- **ARTICLE 5:** We believe that he who endures to the end, the same shall be saved. Matthew 10:22, 24:13, Hebrews 3:12, 10:38-39, Revelation 2:10.
- **ARTICLE 6:** We believe in the resurrection of the body, the just and the unjust, but every man in his own order, those who have done good, to eternal life, those who have done evil, to eternal damnation and that God has appointed a day in which He will judge the world in righteousness by Jesus Christ. Daniel 12:2, Matthew 25:46, Acts 17:31.
- **ARTICLE 7:** We believe that the joys of the righteous and the punishment of the wicked are eternal. Daniel 12:2, Matthew 25:46, Romans 5:21.
- **ARTICLE 8:** We believe that Baptism, the Lord's Supper and feet washing are ordained of Christ appointed in the Church and none but true believers are proper subjects, and that immersion is the Gospel mode of baptism. Matthew 28:19-20, Luke 22:17-20, John 13:14, Acts 2:41, Romans 6:4, Colossians 2:12.
- **ARTICLE 9:** We believe in the sanctity of the first day of the week, or Lord's Day, and it should be spent in public or private worship, and we abstain from worldly concerns, except in case of necessity or mercy. Luke 23:56, John 20:26, Acts 20:7, 1 Corinthians 16:2, Revelation 1:10.
- **ARTICLE 10:** We believe it is our duty to be tender, affectionate to one another, in honor preferring one another, to study the happiness of God's people in general and do all we can to support, promote and spread the Gospel. Isaiah 53:1-10, Romans 12:10, Galatians 6:1-2, 10, 2 Corinthians 9:14.
- **ARTICLE 11:** We believe that Jesus Christ, by the Grace of God tasted death for everyman, that none can partake of His Holy Divine benefits except by repentance toward God and Faith in the Lord Jesus Christ; Infants and the innocent, due to lack of mental ability excepted, they being included in the covenant of God's Grace. Matthew 9:13, Luke 18:15-18, John 3:15-17, Acts 4:12, Romans 5:15, 1 Timothy 2:5-6.
- **ARTICLE 12:** We believe that, at Christ's coming in the clouds of Heaven, all Christians will be gathered with Him in the clouds and that time shall be no more, thus leaving no time for a literal one thousand year reign. Matthew 24:29-31. Revelation 10:6, 1 Thessalonians 4:15-18, 2 Peter 3:10.
- *We believe that non-English speaking people should use a Bible comparable to the King James Version of the Holy Bible.
