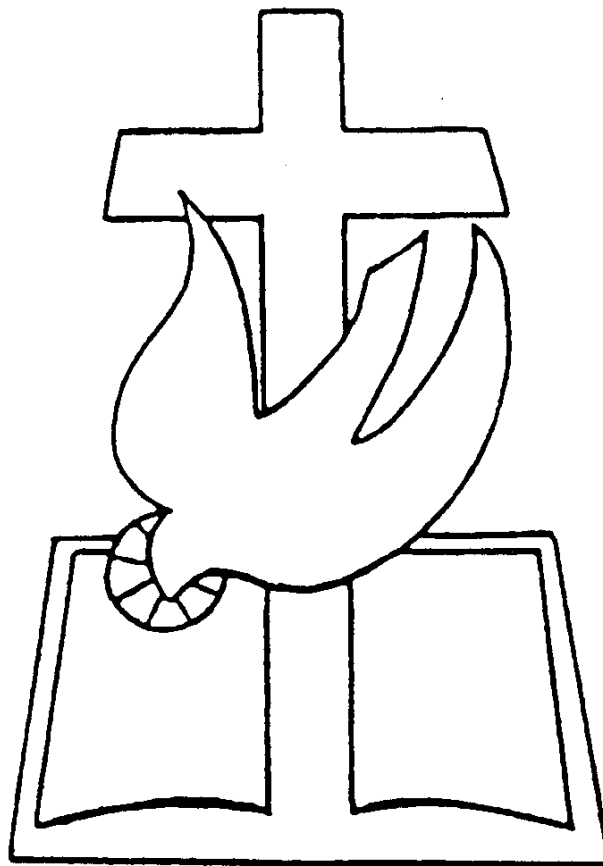

AMERICAN FLAG

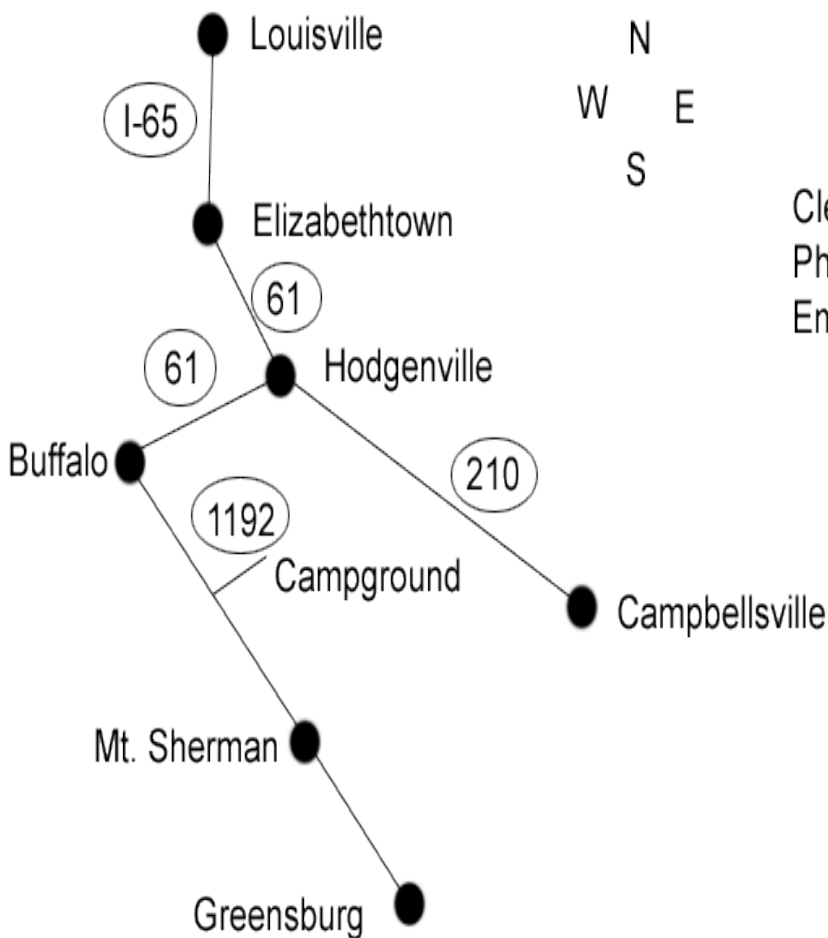
I pledge allegiance to the flag of the United States of America, and to the republic for which it stands; one nation, under God, indivisible, with liberty and justice for all.

PROCEEDINGS

FRIDAY MORNING SESSION

The 187th annual session of the Nolynn Association of Separate Baptist in Christ of Kentucky, Inc. was held at the Nolynn Association Campground in Magnolia, Kentucky on September 15, 2006.

The Friday morning session was opened by an altar of prayer led by Rev. John Davidson. The congregation sang "A Beautiful Life" led by Bro. Herbert Martin accompanied by Bro. Rick Goff. Our moderator, Rev. Jim Goff, led us in the pledges to the American Flag, Christian Flag, and the Bible as the congregation stood. The devotion service was given by Rev. Keith Sullivan, our assistant moderator. He read Psalm 1. We had an altar of prayer led by Rev. Jimmy Polston of Central Indiana.

Reading of the Rules of Order by the clerk was next. The Association body was then called together by the moderator. A total of 16 ministers and 14 deacons were present and in harmony. The moderator had the ministers and deacons stand together and by their silence, they agreed to do business for this setting of the Association.

A call for church letters with Minute money, reading same, and seating delegates was next. Rev. Melvin Underwood made a motion, seconded by Rev. Keith Sullivan to read all church letters under one motion. Motion carried. The following church letters were then read: Calvary Hill, Coral Ridge, Faith, Friendship, Glasgow, Little Barren, Louisville, Mt. Salem, Munfordville, Oak Grove, Okolona, Otter Creek, Pleasant Ridge, Sand Lick, Union, and Zion. The moderator had the appointed delegates and standing delegates to stand and all voted at peace. Rev. Jim Goff then declared the 187th setting of the Nolynn Association in session. A call for letters from new churches was next. There were none. We then recognized visitors from Sister Associations. We had 6 visitors from Central Indiana and South Kentucky to stand. Their names are printed in the Minutes under the heading "Visitors From Sister Associations".

A call for Corresponding Letters being read by Corresponding Secretary was next. The following letters were read by Bro. Wendell Benningfield: Central Indiana and South Kentucky. Bro. Wendell Benningfield made a motion, seconded by Bro. Charles Jordan, to receive the letters and to recognize delegates from Sister Associations. Motion carried. There were three delegates: Rev. Jimmy Polston, Rev. Mark Polston, and Rev. Danny Bailey.

The moderator then appointed the following committees for the 2007 Association. They were: Constitution (Rev. Nolan Howell - chairman, Rev. Eudell Stilts, Bro. Rick Goff, Bro. Wendell Benningfield, Bro. Charles Jordan), Enrollment (Sis. Laquinta McKinney - chairperson, Sis. Shelby Wolford, Sis. Suvada Arnett), Association Revival (Bro. Olyn Spowles - chairman, Bro. Noah Vance, Bro. Jesse Thompson), Communion and Feetwashing (Bro. Arnold Stidham - chairman, Bro. Winfred Simpson, Bro. Arnold Spowles), and Workshop (Bro. Rick Goff – chairman, Sis. Diane Elliott, Bro. Charles Jordan). Rev. Gerald Gardner will remain as the SBMI member for the coming year.

Rev. Ronda Arnett came forward to preach the Introductory Sermon. He read St. Matthew 3:1-7. Rev. Ronda preached how we're in the wilderness right now. There are so many religions out there to suit everyone. We need to study our Bible so that we're not lead astray. There are only two places after death: Heaven and Hell. We need to get ready for our time to come by repenting. Be not deceived. "The only way that you can come to my Father is to be drawn." God said to make your path straight. We're going to be judged on how we live our lives

here on earth. He asked, "How much do we love God's Word?" We need to be using and studying our Bibles more than our cell phones. We're going to give account for every idle word. We don't need to wait to get things right because it may be too late. There's a day coming when it's ALL going to count. Rev. Ronda preached on the final days according to the Bible. "Are we really seeing this as serious as we should? It's time we get down to business."

We then had a Christian handshake as Bro. Arnold Sprowles, accompanied by Sis. Shannon Kennedy, led us in "It's a Grand and a Glorious Feeling", "Heaven's Jubilee", and "Victory in Jesus". We had numerous testimonies to follow.

The clerk read a partial report of the Divine Committee. Rev. Melvin Underwood made a motion to accept the report, seconded by Bro. Randy Kennedy, and motion carried. The clerk read Mt. Zion's church letter and seated the delegates. Rev. Melvin Underwood made a motion to accept the letter and seat the delegates, seconded by Bro. Arnold Sprowles, and motion carried. Bro. Charles Jordan discussed and handed out some surveys.

The blessing on the noon meal was given by Rev. Robert Gosser, and the dismissal was prayed by Rev. Mark Polston. We were adjourned until 1:00 PM.

FRIDAY AFTERNOON SESSION

The Friday afternoon session was called together by collecting a freewill offering for the Association. Bro. Olyn Sprowles prayed the blessing on the offering. Bro. Wendell Benningfield led the congregation in singing "Glory to His Name" accompanied by Sis. Shannon Kennedy as a total of \$390 was received in offering.

The devotion was given by Rev. Nolan Howell. His scripture was Psalm 100. We then went to the Lord in prayer led by Rev. Charlie Houk.

The Obituary report was read and the widows of deceased ministers and deacons and spouses of deceased members of the Nollynn Association were recognized. A motion was made by Bro. Randy Kennedy, seconded by Rev. Melvin Underwood, to accept the report and print it in the Minutes. Motion carried. A total of three members stood to be recognized in memory of those who had passed away as the moderator called on Rev. James Hale to pray the memorial prayer.

Rev. Charlie Houk came forward to preach the memorial sermon. He read Exodus 16:12-33. Bro. Charlie pointed out how God provided His people with what they needed. He posed the question to us to think about what a memorial is. He said that we all have a job to do while we're here on earth. We have no excuses not to be working for the Lord. He preached about the conversation between the Lord and Peter when the Lord instructed Peter to feed His sheep. Bro. Charlie preached on the duties of a preacher and linked it to the scripture. He preached on how our "memorials" have laid out the path for us to follow. How much have we let go since they've been gone? We've become too numb to today's sins. Don't forget our memorials. The manna is still plentiful for us to feast on. Go out and gather.

The congregation was then dismissed for the motivational workshop. Rev. Mark Polston spoke on "What Our Beliefs are on the Millennial Reign and Why We Believe Them."

FRIDAY EVENING SERVICE

The Friday evening service was called together with special singing from 6:00 PM to 6:45 PM. Those singing were as follows: Sis. Barbara & Rev. James Hale, Sis. Regina & Bro. Rick Goff, Sis. Amanda Nelson, Sis. Dianna & Rev. Melvin Underwood, Rev. Troy Arnett, Sis. Wilma White, Sis. Cozetta Sprowles, Sis. Holly Howell, Rev. Gerald Gardner, and Bro. David Atwell.

The congregation then sang "What a Day that Will Be" led by Rev. Gerald Gardner accompanied by Bro. David Atwell.

An altar of prayer followed led by Bro. David Randols. Rev. Gerald Gardner came forward to preach the doctrinal sermon. He read from Rev. 1:17c – Rev. 2:9. Rev. Gardner preached that it is important for us to think about church. We need to be careful that we don't lose our love for Christ. Our truth and doctrine are in the Bible. Jesus taught doctrine. What would our thinking be if Jesus came back and admonished our church? He preached that we need "preventative medicine" – things that keep us from falling by the wayside. Church membership is not the best thing. Jesus is the head of the church. God has blessed us. Our love for God has to start in the church. He asked us to reflect on the day that we were saved and how anxious we were to go to church. He preached how our churches are less attended because the love is no longer in their hearts as it used to be. Jesus started one institution and that was the church. Rev. Gerald

preached about the three ordinances. He then preached on how Judas fell from Christ.

The deacons, led by Bro. Jesse Thompson and the Communion and Feetwashing Committee, had charge of the communion service and washing of the saints' feet. There were approximately 31 that took part in the service. After several songs and spirit-filled testimonies, we all sang a song and went out.

New and miscellaneous business was next. The clerk announced the topic for next year which is "History of the Bible and Why We Prefer the KJV Bible". The clerk reread the Trustee Report for those who missed Friday. The clerk announced minor changes to the Association Revival, Communion and Feetwashing, and Youth Encouragement committees. The clerk read the Program Committee Report for 2007. Rev. Melvin Underwood made a motion to accept it, seconded by Bro. David Randols, and motion carried.

The SBMI report was given by Rev. Gerald Gardner, our 2005-2006 SBMI representative. Rev. Melvin Underwood made a motion, seconded by Bro. Arnold Stidham, to accept the report and print it in the Minutes. Motion carried.

Rev. Danny Bailey of the South Kentucky Association came forward to preach the mission sermon. He read from II Kings 7:1-16. Rev. Bailey preached on the four leprous men who were starving much like the Samaritan city. Rev. Danny shared with us how he, as like us at one time, was starving...spiritually. He compared the story in the scripture to starving Separate Baptists. We are not doing well if we don't share the legacy of Jesus Christ with others. Sinners don't

need to be condemned; they need to be convicted. What are we doing in our movement to replace those who leave or pass away? If we sit around too long, we're going to "die". When people see a change in our lives, they will believe it. If you claim that you have "it", you better have "it". Churches that are growing have people that are excited about their church and what they have. We have the best news that the world has to offer. We need to be excited about the news of Jesus Christ, and what he has offered to everyone of us. Rev. Danny touched on several Bible examples where the people were excited about the news of our Messiah. We don't need to put our faith in people, but in Jesus. He preached on the meeting of John the Baptist and Jesus and how John's purpose in life was to baptize Jesus. He preached on the excitement that Mary and the Disciples had when they discovered that Jesus had risen! Didn't we all want to tell someone when we were first saved? What's happened to us? We should be happy people. We shouldn't shun the sinners. We have the message and good tidings that they need. We need to be doing "the will of the One that's in us". Hard times come in our lives, but we have someone to give us strength to carry us through our problems. We have the "living water".

Bro. Bobby Arnett prayed the blessing over the offering for missions. Bro. Rick Goff, accompanied by Bro. Keith Brown, came forward to lead the congregation in singing "Victory in Jesus" as the mission offering was collected for a total of \$457.55.

We then recognized Rev. Jim Goff with a standing ovation for his 25 years of service as the Nolynn Association Moderator.

The dismissal of the Saturday morning session was prayed by Rev. Jimmy Mason. The blessing on the noon meal was prayed by Bro. Arnold Stidham. We adjourned to meet back at 1:30 PM.

We also support a resolution to officially define marriage as a holy union between one man and one woman, which should last as long as they both live.

On March 18th, 2006, we had our annual meeting at Mt. Hope Church in Jamestown, KY.

All representatives were in attendance, also Bro. Lonnie Palmer and Bro. Jerry Ridge. Both missionaries spoke to us of their plans once they arrive at the Ivory Coast.

We helped two churches this past year:

1. Great Hope Church with a loan of \$1,500 and a grant of \$1,200. They have paid back the loan already.
2. Franklin Church with a loan of \$2,000 and a grant of \$4,000 in which they paid both of these back already.

Bro. Jerry is returning to the Ivory Coast in January, and already has money for his trip. He left church there \$1,200 to rent a building for services. He will be helping buy ground for a church in Abidjan when he returns.

On his last trip, he left in October and returned December 6th. He visited every village where there were Christians and evangelized also. One place, one was saved and eleven saved at another place.

We have \$20,546.78 in the Foreign Mission Account and \$17,336.86 in the Home Mission Fund. Thanks to all for your support.

TRUSTEE REPORT

We, your trustee committee, are pleased to submit this report for the association year 2005-2006. This has been a wonderful year for us at the campground. Besides the normal maintenance items that are needed each year we have accomplished many of our goals that we set last fall.

We held two painting parties, one last September and one this May. The turnouts were great with around twenty people showing up each time to help get the work completed. First of all we want to personally thank each and every one who came out to help us and we know that God has richly blessed you for all of your efforts to make our campground look better than it has looked in a long time. Much very needed work was accomplished including painting two coats of white paint on the exterior of the sanctuary building, painting the exterior of the bath house and painting the roof of the worker's dorm. We also covered rust spots with paint on the other metal roofs where they were needed. Now all of our buildings

are the same matching color and look much nicer. Wooden doors were installed on the cabinets in the women's restroom and an additional stall was equipped with handicapped assistance bars. The men's restroom received a new coat of paint and new floor tile has been installed in both restrooms. As directed by the association last year, new locks have been installed on the doors and keys have been issued to anyone who has requested one. Now, in order to receive a key you must sign your name that you are responsible for that key and will not knowingly let a copy of the key be made. We have also installed a new podium microphone for the PA system. All of this work was accomplished at no cost to the association through donations of time and material by its members.

Many association members may not be aware that we had an incident with the city water company in May. Someone who was not authorized opened the water pit and turned the water on allowing it to run out of the discharge pipe for a number of days. We do not know how long it ran before the problem was detected but the water bill we received the next month was in excess of \$1,700.00. Our treasurer, Bro. Charlie Jordan, negotiated with the water company and they dropped the charges to a little under \$800.00. This problem has happened before and needless to say, we do not want it to ever happen again. We have therefore installed a locked bar across the cover of the pit to keep unauthorized people from turning the water on. We have also painted the valves with a color code and placed a diagram inside the pit that tells how to operate them.

Once again the trustees encourage, or as Bro. Paul would say, exhort every one who can give a donation to our building fund to do so. The trustees sent out a letter this summer asking for everyone's help in paying this loan off in full. The outstanding balance on our loan has not only costs us thousands of dollars in interest, money that is lost to us forever, but it is also keeping us from completing other needed improvements on the campground because of lack of funds. Paying this loan off is one goal that did not get accomplished this year but with your help and the Lord's blessings, it is our prayer that we can accomplish it soon.

As always, we encourage anyone who has any comments or suggestions for our campground to contact any of the trustee committee members and let us know what you think about our buildings and/or any improvements you might want to make on them. It continues to be our belief that the Lord's house should be taken care of as well, or even better, than our own personal homes. We hope you share this belief. Please pray for us that we, your trustee committee, will be able to accomplish this goal.

On Sunday, September 3rd, I (Michael Jordan) traveled to Marion, KY to attend Pleasant Hill Baptist Church. I met Bro. Wm. Ralph Paris, the church clerk. He told me that the people of the General Association of the Baptist do call themselves "Separate Baptist". He then gave me Minutes from the five associations and a Minute from their General Association. He then asked if Pleasant Hill Baptist Church could correspond with Nolynn Association. I gave him a Minute from the Nolynn Association and told him a letter from the Outreach Committee would be mailed out before the end of the week. A letter of correspondence was mailed out from the Outreach Committee on September the Wednesday 6th.

I then left Marion, KY and traveled three hours to Lynchburg, TN. Using the Minutes from the Duck River Association and a city of Lynchburg map, I found 4 churches. Only one of the four was having Sunday night services, so I attended Head of Hurricane Separate Baptist Church that night. Here I met Elder Charles Nunley, the minister of the church. He was very blessed to hear that there are Separate Baptists up in Kentucky because he thought that they were the only Separate Baptists left. He then invited me to attend the Mt. Zion Association which will meet the 21st, 22nd, and 23rd of October. He then asked me to extend an open invitation to all the Separate Baptists up in Kentucky. He said that we are all more than welcome to come down to the Associations and welcome to attend church if we were ever in Lynchburg.

I told Charles about our Nolynn Association and our General Association. I told him that he is welcome to attend both. He said he would try to attend the General. I also told him that all Separate Baptist are welcome to attend any of our Associations. Charles said that he knows that the Head of Hurricane Separate Baptist Church, the Duck River Association, and General Association would want to correspond with the Nolynn Association, but each body would have to vote on it first. I told him each body will receive a letter by the end of the week.

PERMANENT RULES ADOPTED TO GOVERN THIS BODY

1. Telephone numbers of all ordained ministers of the Association are to be printed in the Minutes.
2. All Association records are to be kept by the Association clerk, including updating the Association's incorporation papers (annually), and the expense of maintaining, recording, and updating these records is to be paid by the Association.
3. All decisions by the Presbytery Board are to be by unanimous vote.
4. Nominations for officials of the Association are to be held to a maximum of three. An official must receive a majority of the vote, that is to say more than 50% of the vote to be elected. If on the first ballot a majority vote is not received by candidate, then the man with the lowest number of votes is dropped, and the vote is taken again.
5. All appointments of committees are to be on a one year minimum basis.
6. The Association is to take up a special offering for support and upkeep of the campground.
7. The Association Trustees are to see that the buildings and grounds are kept neat.
8. Any minister OUTSIDE of our Association that is called to pastor a church in the Nolynn Association must get approval of our Presbytery Board.
9. We are to nominate some or part of our elderly ministers to the Presbytery Board.
10. The widows present of all deceased ministers and deacons of our Association are to be recognized during the setting of the Association.
11. The Standing Committee Meeting shall convene at 3:30 PM, and the Ministers and Deacons Business Meeting shall convene at 7:30 PM each year on the third Saturday in August at the campground for the purpose of preparing their reports for the Association.
12. The Association Revival is to be held on the Sunday following the third Saturday in August and continue through and ending the following Friday.
13. Revival offerings are to be divided as follows: The Association Revival evangelist(s) be paid \$400 or half of the offerings taken in the revival, whichever is greater.
14. The Association is to have an Association Bible School and Youth Camp with the starting date to be set by the Youth Activities Board.
15. The Trustees and their successors of office of Nolynn Association are to have legal authority of all property owned by the Association.

- Article 3** That man is in a fallen state before God and is unable to liberate himself by any ability he possesses by Nature. Romans 8:1-20.
- Article 4** That Salvation, regeneration, sanctification, justification, and redemption are through faith in the life, death, resurrection, ascension, and intercession of our Lord and Savior Jesus Christ. Heb. 9:25; Eph. 4:9; and Rev. 1:18.
- Article 5** We believe he who endures to the end, the same shall be saved. Matt. 24:13; Rev. 2:10.
- Article 6** That the joys of the righteous and the punishment of the wicked will be eternal. Matt. 25:46.
- Article 7** We believe that Baptism, the Lord's Supper and feet washing are ordinances of Jesus Christ appointed in the church and none but true believers are proper subjects and the only proper mode of baptism is immersion of the believers. Rom. 6:3-4; also I Cor. 11:27-29; St. John 13:1-17.
- Article 8** We believe in the sanctity of the first day of the week or the Lord's day which ought to be observed and spent in public or private worship of God, and that we should refrain from our worldly concern, except in cases of necessity or mercy. Article 15 We believe that, at Christ's coming in the clouds of Heaven, all Christians will be gathered with Him in the clouds and that Time shall be no more, thus leaving no time for a literal one thousand year reign. Matt. 24:29-31; Rev. 10:6; and I Thes. 4:15-18.

RULES OF ORDER THAT GOVERN THIS BODY

1. This Association shall be opened and closed with prayer.
2. The speaker shall adhere strictly to the subject and in no wise reflect on the person who spoke before him by pointing out his failure, but shall state matter clearly as possible to convey fully his light and ideas.
3. No person shall abruptly break off or absent himself from the body without the consent of the moderator.
4. No member shall laugh or whisper so as to interrupt during public speech.
5. Members shall address each other by the appellation of brother or sister or brethren or sisters.
6. The moderator shall not interrupt any member or prohibit him from finishing his speech unless he fails to abide by the rules of the body.
7. Names of members shall be enrolled by the clerk and called over as often as the body shall require.
8. The moderator shall have the same right of speech as any other member; provided the chair is filled. But he shall not be entitled to vote unless the body is equally divided.
9. That there be no amendment to the Constitution that in any way contradicts or destroys our present Constitution.
10. The Association shall forbid selling sundries on the church ground during the setting of the Association.

CONSTITUTION

We the Separate Baptist of the Nolynn Association of Separate Baptist in Christ of Kentucky having been in existence as said Association since 1819 in the State of Kentucky and having been the governing body for all the churches in this Association, in order to set out and clarify the powers and duties of this Association do ordain and establish this Constitution as follows:

Article I

The Nolynn Association of Separate Baptist in Christ of Kentucky is the governing body of all Separate Baptist churches within this Association.

Article II

This Association shall meet each year on the Friday before the 3rd Saturday in September at the Nolynn Association Campground, subject to change only by assembly vote. Special meetings may be called by the Association at any time it is deemed necessary.

Article III

All ordained Separate Baptist ministers and deacons of the churches in this Association are standing members of the Association. Each church shall send to the annual assembly seven Separate Baptist lay members as delegates and two Separate Baptist lay members as alternate delegates. Each member at the Association has a vote. By majority vote, the Association will adopt and change the type rules of order desired.

Article IV

The Association shall have a moderator, an assistant moderator, a clerk, and a treasurer. Each shall be elected by the Association and each shall serve for a period of one year or until their successors are elected.

Article V

The moderator shall select committees at any time to assist in the administration of any affairs concerning the Association and any of the churches.

Article VI

This Association shall have a Presbytery Board composed of three ordained ministers of the Nolynn Association of Separate Baptist. They shall serve three year terms, one expiring each year. The third-year member shall serve as chairman. Also, the Presbytery shall have two alternate members serving two-year terms, one elected each year. Members of this Board are subject to dismissal by the Association only, or by resignation.

In case of sickness or death, or where a candidate is closely related to a regular member, or where prejudice or partiality is involved, the regular member must step aside and the first alternate will serve in his place. If a vacancy exists, the first alternate shall become a regular member.

Article VII

All ministers and deacons shall be ordained by the Presbytery Board. The manner in which this shall be performed is as follows:

- (a) Any person selected by the church to become a deacon of that church shall first present said person to the Presbytery Board so that they along with any officials of the church, may investigate said person and pass on his qualifications to become a deacon. After this, such person shall serve in this position with the church as an apprentice for a period of twelve months. Upon expiration of the apprenticeship and if such person has been proven to be qualified for and worthy of the position, the Presbytery shall ordain such person and grant him license. This shall be by unanimous vote only. If at anytime the church, the Presbytery, or the Association believes said person shall be unqualified for or unworthy of this position, this person shall be investigated by and heard by the Board. If found by the Presbytery to be unqualified for and no longer worthy of this position, the deacon shall be disordained by the Presbytery and this shall be reported to the Association.
- (b) Any person selected by the church as one called by God to the office of a minister shall be presented to the Presbytery Board, and the Board, along with the officials of the church, shall hear said person and investigate said person for the purpose of ascertaining the fitness and ability of such person to become a Separate Baptist minister. If approved for apprenticeship, such person shall serve a term of twenty-four months as an apprentice with a church in this Association. Upon expiration of the apprenticeship and having proven qualified and worthy of the office of minister and fully indoctrinated as to the doctrines of the Separate Baptist faith, such person shall be ordained as a Separate Baptist minister by the Presbytery Board and license granted by the Board. A card will be presented at such time to such person and shall be reissued yearly by the Board. The ordaining of all ministers by the Board shall be by unanimous vote. If at any time it is believed by the church or the Presbytery or the Association that any minister has been unqualified for or unworthy of the office of a Separate Baptist minister, then said minister shall be presented to, heard by, and investigated by the Presbytery Board. If found by the Presbytery Board to be unworthy of this position, the credentials of said person shall be suspended by the Board.
- (c) No minister shall pastor a Separate Baptist church in this Association unless such person is a fully ordained minister of the Separate Baptist in Christ.
- (d) Any minister that leaves the Separate Baptists and joins another denomination of churches shall no longer be considered an ordained Separate Baptist minister. If such event does take place and such person desires to come back and join the Separate Baptist as a minister, then such person cannot pastor a Separate Baptist as a minister unless such person is re-ordained by the Presbytery Board.

- (e) All deacons and ministers are required to live and conduct themselves in a Christian manner and be in harmony with the Association at all times. The standard of conduct and doctrines of the Separate Baptists required of Separate Baptist ministers and deacons shall be determined by the Presbytery at all times.

- (f) All ordained ministers are accountable to the Association. In order to know what our ministers are doing, at the annual Association, all ordained ministers will present or send a written report to the Association concerning his ministry for the past year. If the minister is sick or there is a death in the family, he would have thirty days to notify the Chairman of the Presbytery as to the reason for failing to report to the Association. The Presbytery Board will be responsible for giving the name of those who failed to report to the clerk. The clerk would then delete those names from the Minute Book, and their card will be withheld. Steps to have the name of the minister restored in the Minute Book and to receive a card again are as follows:
 - 1) The clerk from said minister's church would have to notify the Chairman of the Presbytery Board by letter asking the Board to meet with the church officials and said minister to investigate him.

 - 2) If found by the Board that the said minister shows remorse and wishes to be in good standing again, then the Presbytery Board will recommend his name be restored in the Minute Book at the next Association along with his card being reissued.

Those ministers that are sick and/or elderly and unable to preach will be listed in the Minute Book under the heading of "Honorably Inactive".

- (g) No person shall be ordained who has more than one living wife or whose wife has more than one living husband (I Tim 3:2-12). Therefore, all ordained ministers shall refrain from performing marriage ceremonies between two individuals of the same sex and people who have a living mate (Luke 16:17,18; Gen 2:24; Rom 1:26-32; I Cor 3:10,11).

Article VIII

When the Presbytery Board has been invited by the church, the Presbytery has the right and power (ecclesiastical) to investigate any and all matters coming up in or between any churches or the personnel of any church or churches that might affect the doctrines of the Separate Baptist faith and has the full power to deal with any problems or disputes of any nature as they deem proper.

Article IX

Any persons who desire to unite and form a church under the faith and doctrines of the Separate Baptists shall present themselves or their representatives to the Presbytery Board for the purpose of a full understanding of the orthodox belief of the Separate Baptists. After a letter and messengers to the Association, the moderator shall appoint a committee of three or more to meet with said church to further investigate the orthodox doctrine of the church. If the committee approves in their report the admission of the church into the Association, then same shall be voted upon by the Association, and if the vote is favorable, they shall be in full fellowship.

Article X

If the time should come that a church desires to withdraw from the Association and not be governed by same, the reason for same shall be presented to each and every member of the church. The church shall then meet and vote, and if a majority of them desire to withdraw, then they shall prepare a letter and meet the Association at the regular meeting or a special called meeting. The church shall present their letter of aggrievements to the Association, and the Association shall appoint a committee of three or more to meet with the church and try to reconcile their aggrievements. If no reconciliation is made, then the matter will be presented to the Association, and the church will then receive a letter of dismissal.

Article XI

All officers of this Association shall be elected by nomination and secret ballot.

Article XII

All amendments to this Constitution shall be by 2/3 vote of the delegates to the Association.

Article XIII

The Association may adopt by-laws for the administration of its church affairs and in governing the churches at any time by majority vote of the Association.
