



PROCEEDINGS

FRIDAY MORNING SESSION

The 197th annual session of the Nolynn Association of Separate Baptist in Christ of Kentucky, Inc. was held at the Nolynn Association Campground in Magnolia, Kentucky on September 16, 2016.

The Friday morning session was opened by prayer led by Rev. Troy Arnett. The congregation sang "Just a Little Talk with Jesus" led by Bro. Frankie Young accompanied by Bro. Rick Goff. Our moderator, Rev. Melvin Underwood, led us in the pledges to the American Flag, Christian Flag, and the Bible as the congregation stood. The devotion service was given by Rev. Neal Price. He read part of Job 14:15. We had an altar of prayer led by Bro. Bobby Warren.

Reading of the Rules of Order by the clerk was next. The Association body was then called together by the moderator. A total of 12 ministers and 16 deacons were present and in harmony. The moderator had the ministers and deacons stand together and by their silence, they agreed to do business for this setting of the Association.

A call for church letters with Minute money, reading same, and seating delegates was next. Rev. Eudell Stilts made a motion, seconded by Rev. Jerry Scott to read all church letters under one motion. Motion carried. The following church letters were then read: Calvary Hill, Coral Ridge, Faith, Friendship, Glasgow, Little Barren, Louisville, Mt. Salem, Mt. Zion, Munfordville, Oak Grove, Okolona, Otter Creek, Pleasant Ridge, Sand Lick, Union, and Zion. Bro. Rick Goff made a motion to accept the letters with any needed additions and corrections and seat the delegates. Bro. Charles Jordan seconded the motion. Motion carried.

The moderator had the appointed delegates and standing delegates to stand and all voted at peace. Rev. Melvin Underwood then declared the 197th setting of the Nolynn Association in session. Our moderator asked the trustees during the setting of this association to make a recommendation regarding the closing of the Glasgow Separate Baptist Church. A call for letters from new churches was next. There were none. We then recognized visitors from Sister Associations. We had 9 visitors from South Kentucky and Bethlehem to stand. Their names are printed in the Minutes under the heading "Visitors From Sister Associations" and "Non-Sister Associations".

A call for Corresponding Letters being read by the Corresponding Secretary was next. Bro. Barry Arnett made a motion to read all of the letters under one motion, seconded by Bro. Charles Jordan, motion carried. The following letters were read by Bro. Randy Kennedy: Christian Unity, South KY, and Bethlehem. Bro. Randy Kennedy, made a motion, seconded by Bro. Barry Arnett, to receive the letters and print them in the minutes. Motion carried.

The moderator then appointed the following committees for the 2017 Association. They were: Arrangements (Sis. Shelly Gribbins – chairperson, Sis. Diane Walters, Sis. Sue Sprowles, Sis. Linda Sprowles), Constitution (Rev. Ronda Arnett - chairman, Bro. Rick Goff, Rev. Neal Price, Bro. Wendell Benningfield, Bro. James White), Enrollment (Sis. Jane Penick - chairperson, Sis. Edith Warren, Sis. Irene Sprowles), Association Revival (Bro. Gary Reynolds - chairman, Bro. Olyn Sprowles, Bro. Winfred Simpson), 200th Anniversary Committee (Bro. Charles Jordan – chairman, Rev. Neal Price, Bro. Rick Goff, Sis. Regina Goff, Sis. Charlotte Jordan, Sis. Laura Price), Communion and Feetwashing (Bro. Charles Jordan - chairman, Bro. James Warren, Bro. Buddy Sprowles), Outreach (Bro. Michael Jordan – chairman, Bro. Randy Kennedy, Bro. Charles Jordan), Home

Missions (Bro. Rick Goff – chairman, Rev. Eudell Stilts – treasurer, Rev. Jerry Scott), Youth Encouragement (Sis. Shannon Kennedy – chairperson, Sis. Cindy Scott, Sis. Rena Sprowles). Bro. Olyn Sprowles will be the SBMI member for the coming year. Bro. James White was appointed as the new Standing Committee chairman.

The moderator had Bro. Orville Walls bless the freewill offering as Bro. Frankie Young, accompanied by Sis. Stacy Skaggs, came forward to lead us in singing "Victory in Jesus". A total of \$678 was collected.

Rev. Arnold Sprowles came forward to preach the Introductory Sermon. He read from Joshua 24:1-15. Rev. Arnold told us that the Lord wants us to serve Him and be the best servant that we can be for Him. The Lord gives us the choice to serve Him or serve the devil every day we are able to rise in the morning. The Lord takes care of us so much each day. Why would we not want to serve Him the best we can? We need to make sure that we get behind our young people and help them during their growth as Christians.

Rev. Arnold turned the service back to the moderator. The clerk read a partial report of the Divine Committee. The clerk announced that Bro. David Kerns will be the new Standing Committee member for Calvary Hill. Rev. Melvin mentioned how many great years that Rev. James Hale has served our association since he was the one stepping down from the Standing Committee. Bro. Randy Kennedy made a motion to accept the partial Divine Committee Report, seconded by Bro. Barry Arnett. Motion passed.

The dismissal was given by Rev. Terry Thrasher, and the blessing on the noon meal was prayed by Bro. Frankie Young. We were adjourned until 1:00 PM.

FRIDAY AFTERNOON SESSION

The Friday afternoon session was called together by singing "That Glad Reunion Day" led by Bro. Frankie Young accompanied by Sis. Stacy Skaggs. Rev. Eudell filled the moderator's chair for the afternoon session.

The devotion was given by Rev. Silas Thrasher of South KY. He read from John 14:8-14. We had an altar of prayer following.

The Obituary report was read. Motion carried to accept the report. A total of 3 widows (Sis. Phyllis Perkins, Sis. Suvada Arnett, Sis. Wanda Coffey) stood to be recognized in memory of those ministers, deacons, and members that have passed away. Rev. Ronda Arnett prayed the memorial prayer.

Rev. Jerry Scott came forward to preach the memorial sermon. He read from Joshua 4:1-7. There is hope for us because the stone was rolled away, and Jesus Christ arose! The brethren and sisters that have passed away are in a better place. They are home. We all have a memorial place. Rev. Jerry preached that we need the Lord back in our homes, families, church, and government. As a Christian, we take on a responsibility to share the gospel and live a holy life. As long as we are down here on earth, we might as well work for God. God's work is what truly matters in this life. Our main priority on Sunday morning should be nothing less than going to the house of the Lord and worshipping Him. As long as we have God, that's all we need.

Rev. Jerry turned the service back to Rev. Eudell.

The clerk read the minutes of the Friday morning session. Bro. Randy Kennedy made a motion, seconded by Bro. Barry Arnett, to receive them as read with any needed corrections or additions and print them in the form of minutes. Motion carried.

Bro. Randy Kennedy made a motion to read all treasury reports under one motion, seconded by Bro. James Warren. Motion carried.

Treasury reports were read and accepted as follows: Nolynn Treasury, Youth Camp, Dorm Fund, Shower House Fund, Lincoln National Account, Upper Room, Northern SS Treasury, Southern SS Treasury, Home Mission Fund, Kitchen Fund, Trust Fund.

All treasury reports read were referred to the Audit Committee.

The Association business session was next which included unfinished, new, and miscellaneous business. The following report(s) were read and accepted:

Northern SS, Southern SS.

The call for Committee reports was next. They were read and accepted as follows: Home Mission Fund, Condition, Resolutions, Association Revival Committee, Presbytery Board, Trustee, Standing Committee (partial).

The service was dismissed in prayer by Bro. Gary Reynolds. We adjourned until evening service at 6:00 PM.

FRIDAY EVENING SERVICE

Our assistant moderator, Rev. Eudell Stilts, had charge of the service tonight. Rev. Troy Arnett led us in singing "He Set Me Free", accompanied by Bro. Rick Goff. Rev. Eudell asked for prayer requests, and we then had an altar of prayer.

Special singing went from 6:00 PM to 7:00 PM. Those singing were as follows: Sis. Cozetta Sprowles, Bro. Teddy Perry, Rev. Neal Price, Bro. Rick and Sis. Regina Goff, Rev. Jim Hale, Rev. Troy Arnett, Sis. Frieda Benningfield, Bro. Barry Arnett,

Rev. Verlin Perry came forward to preach the doctrinal sermon. He gave us his testimony. He told us how the Lord called him to preach. All of us want a sign to inform us that we are making the right decisions in life. The signs are all around us. We look, but we don't always see. Rev. Verlin read from I Peter 2:21-25. God is in control of all things. He is the Shepherd of the sheep. Rev. Verlin preached about how God always provides by using the story of Abraham and Isaac. The world is in its current state because the world is looking in the wrong direction. God's light is still the light shining in the world even in darkness. All the world needs is a little dose of salvation. Rev. Verlin concluded with a prayer for those suffering with cancer and other sicknesses.

The deacons, led by Bro. Billie Grimes and the Communion and Feetwashing Committee, had charge of the communion service and washing of the saints' feet. Bro. Billie turned the service over to Bro. Brian Sprowles, to take charge of the service. Rev. Troy Arnett led the congregation in singing "I'd Rather Be An Old-Time Christian" and "A Beautiful Life", accompanied by Sis. Imogene Warren, as the deacons prepared for the service. Sis. Holly Howell sang "I'd Rather Have Jesus". Bro. Brian had Bro. Billie Grimes ask the blessing over the cup and the bread. Bro. Brian read Mathew 26:26-28. The body then took the bread and cup. Bro. Brian read John 13:1-17. The congregation and individuals sang songs while finishing the footwashing portion of the service. There were 40 that took part in the service. After many spirit-filled testimonies, we all sang a song and went out.

SATURDAY MORNING SESSION

The Saturday morning session was opened by prayer led by Rev. James Crim. Bro. Bobby Warren blessed the morning offering. Bro. Rick Goff led us in singing "It's a Grand a Glorious Feeling" accompanied by Bro. Keith Brown while a total of \$615 was received in a freewill offering for the Association.

The moderator then recognized visiting Sisters and Brethren from sister associations and non-sister associations. New ones from yesterday was Rev. Jerry Ridge and Bro. Bill Ridge both from Central Indiana Association.

Elder Steve Nida of the Bethlehem Association had charge of the devotion. Bro. Teddy Perry of the Bethlehem Association stood up and read some scripture. An altar of prayer followed and was led by Rev. Neal Price.

Roll call of delegates of the churches was next.

Our moderator deviated from the program to have Bro. Charles Jordan speak to the body concerning current Nolynn Association finances. Bro. Charles Jordan also requested to take up a special offering for the General Association to offset costs for this year's setting of the association in North Carolina. Bro. Rick Goff led us in singing "When He Put a Little Sunshine In", accompanied by Bro. Keith Brown, as a total of \$670 was collected.

The reading of the minutes of the Friday afternoon session and Friday evening service was next. A motion was made by Bro. Randy Kennedy to accept them as read with any needed corrections or additions and print them in the form of Minutes. After a correction, Bro. Barry Arnett seconded the motion. Motion carried.

Unfinished business was called for by the moderator. The clerk had the corresponding secretary, Bro. Michael Jordan, to come before the body to read the Central Indiana corresponding letter. Bro. Keith Brown made a motion to accept it and print it in the minutes, seconded by Bro. Rick Goff, and motion carried. The Union Association of United Baptist corresponding letter was then read. Bro. Charles Jordan made a motion to accept it and print it in the minutes, seconded by Rev. James Hale, and motion carried.

New and miscellaneous business was next.

The following motion was made: The Outreach Committee would like to make a motion to have Nolynn Association correspond with and send delegates to the following associations: Bethlehem, Centerpoint, Wills Creek, Ancient Christian, and Union Associations. Motion carried to print it in the minutes.

The following motion was made: The Outreach Committee would like to make a motion to have Nolynn Association Moderator extend the right hand of fellowship to all the visiting delegates from other associations. After discussing that it happened yesterday, a vote was taken and motion failed.

The following motion was made: The Outreach Committee would like to make a motion to have Nolynn Association put the dates of all the non-district associations that we correspond with printed in the minute book, and make sign-up sheets and folders for all the non-district associations. Motion carried.

The 2017 Association Revival Committee report was read and accepted to print in the minutes.

The SBMI report was given by Bro. Randy Kennedy upon request by Bro. Olyn Sprowles, our 2015-2016 SBMI representative. Bro. Charles Jordan seconded the report to be printed in the Minutes. Motion carried. Bro. Olyn Sprowles relinquished his SBMI speaking time to Rev. Jerry Ridge to share his and the group's experiences in the Ivory Coast from this past year.

Rev. Danny Bailey of the South KY Association came forward to preach the mission sermon. Rev. Danny read from Proverbs 30:11-20 and Psalms 2:1. He

preached how we are a whiny nation and whiny Christians. He said that children left unattended will become disrespectful to parents and to the rest of society. We have allowed a generation grow up thinking that everyone is a winner even when they are only participants. People want more and more and get less satisfied. We as church people complain about the condition of the world while at the same time not standing our ground. Rev. Danny preached that we were not commanded to just preach in our "little boxes", but to go out and share our voice in America. He preached how abortion and gay marriages are not political issues; they are MORAL issues! It's the moral laws of God that are important, and we need to make sure that we uphold them and teach them. "It's time that we stop whining about the generation that we live in and start changing the generation that we live in."

Bro. Charles Jordan prayed the blessing over the offering for missions. Bro. Rick Goff, accompanied by Bro. Keith Brown, came forward to lead the congregation in singing "I've Got That Old Time Religion in My Heart" as the mission offering was collected for a total of \$751.00.

The blessing on the noon meal was prayed by Bro. Bill Ridge. The dismissal of the Saturday morning session was prayed by Rev. Jerry Ridge. We adjourned to meet back at 1:30 PM.

In 1872, Bethlehem Association of United Baptist was organized by the Zion Association of United Baptist.

In 1819, the Nolynn Association of Separate Baptist was organized by the South Kentucky Association of Separate Baptist.

To help these associations learn more about us, the Outreach Committee is requesting 75 minute books. The Outreach Committee fully supports fellowship and correspondence between the Nolynn Association and following Associations: Bethlehem, Centerpoint, Wills Creek, and Ancient Christian.


Sis. Evelyn Hedgespeth (October 12, 1926 – March 28, 2016)

PERMANENT RULES ADOPTED TO GOVERN THIS BODY

- 1. Telephone numbers of all ordained ministers of the Association are to be printed in the Minutes.
- 2. All Association records are to be kept by the Association clerk, including updating the Association's incorporation papers (annually), and the expense of maintaining, recording, and updating these records is to be paid by the Association.
- 3. All decisions by the Presbytery Board are to be by unanimous vote.
- 4. Nominations for officials of the Association are to be held to a maximum of three. An official must receive a majority of the vote, that is to say more than 50% of the vote to be elected. If on the first ballot a majority vote is not received by candidate, then the man with the lowest number of votes is dropped, and the vote is taken again.
- 5. All appointments of committees are to be on a one year minimum basis.
- 6. The Association is to take up a special offering for support and upkeep of the campground.
- 7. The Association Trustees are to see that the buildings and grounds are kept neat.
- 8. Any minister OUTSIDE of our Association that is called to pastor a church in the Nolynn Association must get approval of our Presbytery Board.
- 9. Any minister or deacon, coming from any other Association, desiring to become a member of one of the churches of this Association, must get approval of our Presbytery Board before coming in as an ordained official of the Nolynn Association.
- 10. We are to nominate some or part of our elderly ministers to the Presbytery Board.
- 11. The widows present of all deceased ministers and deacons of our Association are to be recognized during the setting of the Association.
- 12. The Standing Committee Meeting shall convene at 5:30 PM each year on the third Saturday in August at the campground for the purpose of preparing their reports for the Association.
- 13. The Association Revival is to be held on the third Sunday in July and continue through and ending on the following Friday.
- 14. Revival offerings are to be divided as follows: The Association Revival evangelist(s) be paid \$400 or half of the offerings taken in the revival, whichever is greater.

- 6. Any participation in gambling (buying chances, playing the lottery, casinos, etc.) as they are sinful before God. Prov. 13:11; Prov. 23:5; Eccl. 5:10; Matt. 6:24; I Tim. 6:10; Heb. 13:5
- 7. Evil use of the mediums of the Internet, television, radio programs, books and publications. Thus, we should closely monitor ours and our family's use of these. Prov. 22:6; Matt. 26:41; I Thess. 5:22

The Bible also teaches us to respect the sanctity of human life, both of the born and the unborn. Thus, all suicide, euthanasia, or mercy killing and abortion are murder and are biblically forbidden. Jesus said, "Let your light so shine before men, that they may see your good works, and glorify your Father which is in Heaven." (Matthew 5:21, James 2:11)

*Any changes to this Report shall require a 2/3 majority vote and shall be tabled for one year.

RULES OF ORDER THAT GOVERN THIS BODY

- 1. This Association shall be opened and closed with prayer.
- 2. The speaker shall adhere strictly to the subject and in no wise reflect on the person who spoke before him by pointing out his failure, but shall state matter clearly as possible to convey fully his light and ideas.
- 3. No person shall abruptly break off or absent himself from the body without the consent of the moderator.
- 4. No member shall laugh or whisper so as to interrupt during public speech.
- 5. Members shall address each other by the appellation of brother or sister or brethren or sisters.
- 6. The moderator shall not interrupt any member or prohibit him from finishing his speech unless he fails to abide by the rules of the body.
- 7. Names of members shall be enrolled by the clerk and called over as often as the body shall require.
- 8. The moderator shall have the same right of speech as any other member; provided the chair is filled. But he shall not be entitled to vote unless the body is equally divided.
- 9. That there be no amendment to the Constitution that in any way contradicts or destroys our present Constitution.
- 10. The Association shall forbid selling sundries on the church ground during the setting of the Association.

CONSTITUTION

We the Separate Baptist of the Nolynn Association of Separate Baptist in Christ of Kentucky having been in existence as said Association since 1819 in the State of Kentucky and having been the governing body for all the churches in this Association, in order to set out and clarify the powers and duties of this Association do ordain and establish this Constitution as follows:

Article I

The Nolynn Association of Separate Baptist in Christ of Kentucky is the governing body of all Separate Baptist churches within this Association.

Article II

This Association shall meet each year on the Friday before the 3rd Saturday in September at the Nolynn Association Campground, subject to change only by assembly vote. Special meetings may be called by the Association at any time it is deemed necessary.

Article III

All ordained Separate Baptist ministers and deacons of the churches in this Association are standing members of the Association. Each church shall send to the annual assembly seven Separate Baptist lay members as delegates and two Separate Baptist lay members as alternate delegates. Each member at the Association has a vote. By majority vote, the Association will adopt and change the type rules of order desired.

Article IV

The Association shall have a moderator, an assistant moderator, a clerk, and a treasurer. Each shall be elected by the Association and each shall serve for a period of one year or until their successors are elected.

Article V

The moderator shall select committees at any time to assist in the administration of any affairs concerning the Association and any of the churches.

Article VI

This Association shall have a Presbytery Board composed of three ordained ministers of the Nolynn Association of Separate Baptist. They shall serve three year terms, one expiring each year. The third-year member shall serve as chairman. Also, the Presbytery shall have two alternate members serving two-year terms, one elected each year. Members of this Board are subject to dismissal by the Association only, or by resignation.

In case of sickness or death, or where a candidate is closely related to a regular member, or where prejudice or partiality is involved, the regular member must step aside and the first alternate will serve in his place. If a vacancy exists, the first alternate shall become a regular member.

Article VII

All ministers and deacons shall be ordained by the Presbytery Board. The manner in which this shall be performed is as follows:

- (a) Any person selected by the church to become a deacon of that church shall first present said person to the Presbytery Board so that they along with any officials of the church, may investigate said person and pass on his qualifications to become a deacon. After this, such person shall serve in this position with the church as an apprentice for a period of twelve months. Upon expiration of the apprenticeship and if such person has been proven to be qualified for and worthy of the position, the Presbytery shall ordain such person and grant him license. This shall be by unanimous vote only. If at anytime the church, the Presbytery, or the Association believes said person shall be unqualified for or unworthy of this position, this person shall be investigated by and heard by the Board. If found by the Presbytery to be unqualified for and no longer worthy of this position, the deacon shall be disordained by the Presbytery and this shall be reported to the Association.
- (b) Any person selected by the church as one called by God to the office of a minister shall be presented to the Presbytery Board, and the Board, along with the officials of the church, shall hear said person and investigate said person for the purpose of ascertaining the fitness and ability of such person to become a Separate Baptist minister. If approved for apprenticeship, such person shall serve a term of twelve months as an apprentice with a church in this Association. Upon expiration of the apprenticeship and having proven qualified and worthy of the office of minister and fully indoctrinated as to the doctrines of the Separate Baptist faith, such person shall be ordained as a Separate Baptist minister by the Presbytery Board and license granted by the Board. A card will be presented at such time to such person and shall be reissued yearly by the Board. The ordaining of all ministers by the Board shall be by unanimous vote. If at any time it is believed by the church or the Presbytery or the Association that any minister has been unqualified for or unworthy of the office of a Separate Baptist minister, then said minister shall be presented to, heard by, and investigated by the Presbytery Board. If found by the Presbytery Board to be unworthy of this position, the credentials of said person shall be suspended by the Board.
- (c) No minister shall pastor a Separate Baptist church in this Association unless such person is a fully ordained minister of the Separate Baptist in Christ.
- (d) Any minister that leaves the Separate Baptists and joins another denomination of churches shall no longer be considered an ordained Separate Baptist minister. If such event does take place and such person desires to come back and join the Separate Baptist as a minister, then such person cannot pastor a Separate Baptist as a minister unless such person is re-ordained by the Presbytery Board.

- (e) All deacons and ministers are required to live and conduct themselves in a Christian manner and be in harmony with the Association at all times. The standard of conduct and doctrines of the Separate Baptists required of Separate Baptist ministers and deacons shall be determined by the Presbytery at all times.
- (f) All ordained ministers are accountable to the Association. In order to know what our ministers are doing, at the annual Association, all ordained ministers will present or send a written report to the Association concerning his ministry for the past year. If the minister is sick or there is a death in the family, he would have thirty days to notify the Chairman of the Presbytery as to the reason for failing to report to the Association. The Presbytery Board will be responsible for giving the name of those who failed to report to the clerk. The clerk would then delete those names from the Minute Book, and their card will be withheld. Steps to have the name of the minister restored in the Minute Book and to receive a card again are as follows:
 - 1) The clerk from said minister's church would have to notify the Chairman of the Presbytery Board by letter asking the Board to meet with the church officials and said minister to investigate him.
 - 2) If found by the Board that the said minister shows remorse and wishes to be in good standing again, then the Presbytery Board will recommend his name be restored in the Minute Book at the next Association along with his card being reissued.

Those ministers that are sick and/or elderly and unable to preach will be listed in the Minute Book under the heading of "Honorably Inactive".

(g) No person shall be ordained who has more than one living wife or whose wife has more than one living husband (I Tim 3:2-12). Therefore, all ordained ministers shall refrain from performing marriage ceremonies between two individuals of the same sex and people who have a living mate (Luke 16:17,18; Gen 2:24; Rom 1:26-32; I Cor 3:10,11).

Article VIII

When the Presbytery Board has been invited by the church, the Presbytery has the right and power (ecclesiastical) to investigate any and all matters coming up in or between any churches or the personnel of any church or churches that might affect the doctrines of the Separate Baptist faith and has the full power to deal with any problems or disputes of any nature as they deem proper.

Article IX

Any persons who desire to unite and form a church under the faith and doctrines of the Separate Baptists shall present themselves or their representatives to the Presbytery Board for the purpose of a full understanding of the orthodox belief of the Separate Baptists. After a letter and messengers to the Association, the moderator shall appoint a committee of three or more to meet with said church to further investigate the orthodox doctrine of the church. If the committee approves in their report the admission of the church into the

Association, then same shall be voted upon by the Association, and if the vote is favorable, they shall be in full fellowship.

Article X

If the time should come that a church desires to withdraw from the Association and not be governed by same, the reason for same shall be presented to each and every member of the church. The church shall then meet and vote, and if a majority of them desire to withdraw, then they shall prepare a letter and meet the Association at the regular meeting or a special called meeting. The church shall present their letter of aggrievements to the Association, and the Association shall appoint a committee of three or more to meet with the church and try to reconcile their aggrievements. If no reconciliation is made, then the matter will be presented to the Association, and the church will then receive a letter of dismissal.

Article XI

All officers of this Association shall be elected by nomination and secret ballot.

Article XII

All amendments to this Constitution shall be by 2/3 vote of the delegates to the Association.

Article XIII

The Association may adopt by-laws for the administration of its church affairs and in governing the churches at any time by majority vote of the Association.
